In the matter of ad hoc Tariff for Ground Handling Services to be provided by the M/s Global Flight Handling Services (Pune) Pvt. Ltd. at Pune International Airport, Pune, for the period from 01.10.2021 to 31.03.2022.

The consortium of M/s Global Flight Handling Services Private Limited & M/s BAGS Ground Services Co. Ltd. has been selected through a competitive bidding process by the Airport Operator i.e. Airports Authority of India (AAI) for providing Ground Handling Services at Pune International Airport, Pune. In accordance with the requirements of the RFP, a Special Purpose Vehicle (SPV) named M/s Global Flight Handling Services (Pune) Pvt. Ltd. has been incorporated on 21.02.2021 for providing Ground Handling Services at Pune International Airport, Pune for a period of 10 years, from the Commercial Operation Date.

2. In this regard, the SPV M/s Global Flight Handling Services (Pune) Pvt. Ltd. (GFHSPL) vide mail dated 28.09.2021 has approached the Authority for allowing of the same tariff as approved for the other Ground Handling Service Provider at Pune namely Air India Airport Services Ltd. (erstwhile AIATSL) during the interim period for their GH Services (proposed commencement date 01.10.2021) at Pune International Airport, till the time their regular tariff is determined.

3. M/s Global Flight Handling Services (Pune) Pvt. Ltd (GFHSPL) has informed the Authority that they are in the process of preparation of MYTP for the 1st Control Period (FY 2021-22 to FY 2025-26) and shall submit the same shortly. The Authority notes that as per the Letter of Intent to Award (LOIA) dated 12.01.2021 issued by AAI, on the date of receipt of requisite BCAS security clearance by the SPV, the LOIA shall be deemed as the Letter of Award (LoA). A copy of the requisite security clearance vide BCAS letter dated 22.07.2021 valid for a period of 5 years has also been submitted in this regard

4. The Authority having examined the request, has decided to allow M/s Global Flight Handling Services (Pune) Pvt. Ltd (GFHSPL) to levy the existing tariff as approved for the other Ground Handling Service Provider at Pune namely Air India Airport Services Ltd. (erstwhile AIATSL- ref. Order no. 23/2019-20 dtd: 14.02.2020 and extended further vide Interim Order nos. 67/2020-21 dtd: 25.03.2021 & 18/2021-22 dtd: 15.09.2021), on ad hoc basis, w.e.f. 01.10.2021 to 31.03.2022, or, determination of regular Ground Handling tariff, whichever is earlier.




ORDER

5. Upon careful consideration of the material available on records, the Authority, in exercise of powers conferred by Section 13(1) of the Airport Economic Regulatory Authority of India Act, 2008 hereby orders that:

- (i) M/s Global Flight Handling Services (Pune) Pvt. Ltd (GFHSPL) is allowed to levy and collect, on ad hoc basis, the existing tariff for Ground Handling Services at Pune International Airport, Pune, as approved for the other Ground Handling Service Provider namely Air India Airport Services Ltd. (erstwhile AIATSL) as per attached tariff card at **Annexure-I**, w.e.f. 01.10.2021 to 31.03.2022, or, determination of regular Ground Handling tariff for the 1st Control Period, whichever is earlier.
- (ii) The tariff charged by the SPV M/s Global Flight Handling Services (Pune) Pvt. Ltd (GFHSPL) for Non-Schedule Operations should not exceed the tariff approved by AERA for Scheduled Operations for 'similar class of aircraft.'
- (iii) Tariff approved as above will be the maximum tariff to be charged from the users of the Ground Handling service. No other charges to be levied over and above the approved tariff.
- (iv) The Airport Operator shall ensure compliance of the Order.
