In the matter of Determination of ad hoc Tariff for Ground Handling Services to be provided by M/s Global Flight Handling Services (Patna) Pvt. Ltd. at Jai Prakash Narayan International Airport, Patna for the period from 15.02.2022 to 31.03.2022.

M/s Global Flight Handling Services (Patna) Pvt. Ltd. (GFHSPL) vide letter dated 18.01.2022 informed the Authority that they have been selected through competitive bidding process by the Airport Operator, namely Airports Authority of India (AAI) for providing Ground Handling Services at Jai Prakash Narayan International Airport, Patna. GFHSPL proposes to commence their commercial operations at Patna airport w.e.f. 15.02.2022.

2. GFHSPL has submitted copies of Letter of Award dated 13.04.2021 issued by AAI in favour of Consortium "Global Flight Handling Services Pvt. Ltd. and BAGS Ground Services Co Ltd.", Security Clearance given by Bureau of Civil Aviation Security (BCAS) & Concession Agreement executed between GFHSPL (SPV incorporated by consortium) and AAI.

3. GFHSPL has approached the Authority with a request to approve the ad hoc Tariff proposed by it in respect of Ground Handling Services to be provided at Patna Airport.

4. The Authority notes that GFHSPL already has a BCAS Security Clearance vide BCAS order dated 27.08.2021, applicable for Patna airport, valid for a period of 5 years from the date of issue of security clearance or the period of validity of contract with the airport operator, whichever is earlier.

5. The Authority, having examined the request of GFHSPL feels that submission of MYTP by the new Service Provider will take some time. The Authority, in the interim, has decided to allow M/s Global Flight Handling Services (Patna) Pvt. Ltd. to levy the ad hoc Tariff, based on the existing Tariff as approved for the other Ground Handling Service Provider at Patna International Airport, namely, Air India Airport Services Ltd. (erstwhile AIATSL- ref. Order no. 23/2019-20 dated 14.02.2020, further extended up to 31.03.2022 vide Interim Order nos. 67/2020-21 dated 25.03.2021 & 18/2021-22 dated 15.09.2021) on ad hoc basis from 15.02.2022 to 31.03.2022, or, till the determination of regular Ground Handing Tariff, whichever is earlier.

<u>ORDER</u>

Upon careful consideration of the material available on records, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008 hereby orders that:

- (i) M/s Global Flight Handling Services (Patna) Pvt. Ltd. is allowed to levy and collect, on ad hoc basis, Tariff for Ground Handling Services at Jai Prakash Narayan International Airport, Patna as per Annexure-I w.e.f. 15.02.2022 to 31.03.2022, or, till the determination of regular Ground Handing Tariff for the 3rd Control Period, whichever is earlier.
- (ii) The Tariff to be charged for Ground Handling Services by M/s Global Flight Handling Services (Patna) Pvt. Ltd for Non-Scheduled Operations should not exceed the Tariff approved by the Authority for Scheduled Operations for 'similar class of aircraft(s)'.
- (iii) Tariff approved, as above, will be the maximum Tariff to be charged from the Users of the Ground Handling Services. No other charges are to be levied over and above the approved Tariff.
- (iv) The Airport Operator shall ensure compliance of the Order.
