In the matter of Determination of ad hoc Tariff for Ground Handling Services to be provided by M/s Indo Thai Airport Management Services Pvt. Ltd., at Lokpriya Gopinath Bordoloi International Airport, Guwahati for the period from 01.02.2022 to 31.03.2022.

M/s Indo Thai Airport Management Services Pvt. Ltd. (IAMS) vide their letter dated 21.01.2022 informed the Authority that they have been selected through RFP selection process by Guwahati International Airport Limited (Airport Operator) for providing Ground Handling Services at Lokpriya Gopinath Bordoloi International Airport, Guwahati. IAMS further informed that as per clause iii of the Letter of Award (LOA), they are required to form a SPV (Special Purpose Company) within 15 days of issuance of LOA.

2. IAMS has approached the Authority for allowing them to charge the same Tariff, as approved for the other Ground Handling Service Provider at Guwahati International Airport, namely, Air India Airport Services Ltd. (erstwhile AIATSL), on ad hoc basis, as their ground handling operations are proposed to commence at Guwahati International Airport **w.e.f. 01.02.2022**.

3. The Authority notes that IAMS has been issued Letter of Award dated 05.01.2022 by the Airport Operator and already has a BCAS Security Clearance vide BCAS order dated 17.11.2020, valid for a period of 5 years from the date of issue of security clearance or the period of validity of contract with the airport operator, whichever is earlier.

4. IAMS has also informed the Authority that they are in process of forming a SPV as per the requirement of LOA.

5. The Authority, having examined the request of IAMS, feels that as per the LOA, the process of incorporation of SPV by IAMS and submission of MYTP by the SPV (to be formed) will take some time. The Authority, in the interim, has decided to allow M/s Indo Thai Airport Management Services Pvt. Ltd., to levy the existing tariff, as approved for the other Ground Handling Service Provider at Guwahati International Airport, namely Air India Airport Services Ltd. (erstwhile AIATSL- ref. Order no. 18/2019-20 dated 22.11.2019, which was further extended up to 31.03.2022 vide Interim Order nos. 67/2020-21 dated 25.03.2021 & 18/2021-22 dated 15.09.2021), on ad hoc basis, from **01.02.2022 to 31.03.2022**, or, till the determination of regular Ground Handling Tariff, whichever is earlier.



ORDER

Upon careful consideration of the material available on records, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008 hereby orders that:

- (i) M/s Indo Thai Airport Management Services Pvt. Ltd. is allowed to levy and collect, on ad hoc basis, the existing Tariff for Ground Handling Services at Lokpriya Gopinath Bordoloi International Airport, Guwahati as approved for the other Ground Handling Service Provider, namely, Air India Airport Services Ltd. (erstwhile AIATSL) as per attached Tariff Card at **Annexure-I** w.e.f. **01.02.2022 to 31.03.2022**, or, till the determination of regular Ground Handling Tariff for the 3rd Control Period, whichever is earlier.
- (ii) The Tariff to be charged by M/s Indo Thai Airport Management Services Pvt. Ltd. for Non-Scheduled Operations should not exceed the Tariff approved by the Authority for Scheduled Operations for 'similar class of aircraft(s).'
- (iii) Tariff approved, as above, will be the maximum Tariff to be charged from the Users of the Ground Handling Services. No other charges are to be levied over and above the approved Tariff.
- (iv) The Airport Operator shall ensure compliance of the Order.
