**In the matter of Order no. 04/2021-22 dated 19.07.2021 regarding ad hoc Tariff Order for Ground Handling Services provided by M/s Bird Airport Services (Mohali) Private Limited at Chandigarh International Airport, Mohali for the period from 19.07.2021 to 31.12.2021 – Extension of ad hoc Tariff Order up to 31.03.2022.**

The Authority, vide Order No. 04/2021-22 dated 19.07.2021, has approved ad hoc tariff of M/s Bird Airport Services (Mohali) Private Limited (BASMPL) for providing Ground Handling Services at Chandigarh International Airport, Mohali for the period from 19.07.2021 to 31.12.2021.

2. In this regard, M/s Bird Airport Services (Mohali) Pvt. Ltd vide their email dated 21.12.2021, has requested AERA to extend the existing tariff approved on ad hoc basis till 31.03.2022.

3. M/s BASMPL, Mohali has also submitted that they are in the process of preparation of MYTP/ATP for regular determination of tariff for the 3<sup>rd</sup> Control Period and shall submit the same at the earliest.

4. The Authority having examined the request, has decided to extend the existing tariffs, as applicable as on 31.12.2021 on ad hoc basis, for a further period of three (03) months w.e.f. 01.01.2022 to 31.03.2022, or, till the determination of regular Tariff, whichever is earlier.

**ORDER**

In view of the above, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airport Economic Regulatory Authority of India Act, 2008 hereby orders that:-

- (i) M/s Bird Airport Services (Mohali) Private Limited (BASMPL) providing Ground Handling Services at Chandigarh International Airport, Mohali is






allowed to levy & collect the existing ad hoc Tariff applicable as on 31.12.2021 for a further period of three (03) months w.e.f. 01.01.2022 to 31.03.2022, or, till determination of regular tariff by AERA for the 3<sup>rd</sup> Control Period, whichever is earlier.

- (ii) The other Terms & Conditions of Order no. 04/2021-22 dated 19.07.2021 shall remain unchanged.
- (iii) M/s Bird Airport Services (Mohali) Private Limited is advised to file the MYTP for 3<sup>rd</sup> Control Period at the earliest.
- (iv) The Airport Operator shall ensure the compliance of the Order.
