**In the matter of Order no. 05/2021-22 dated 29.07.2021 regarding ad hoc Tariff Order for Ground Handling Services provided by M/s GSEC Bird Airport Services Private Limited (GBASPL) at SVPIA, Ahmedabad for the period from 01.08.2021 to 31.12.2021 – Extension of ad hoc Tariff Order up to 28.02.2022.**

The Authority, vide Order No. 05/2021-22 dated 29.07.2021, has approved ad hoc tariff of M/s GSEC Bird Airport Services Private Limited (GBASPL) for providing Ground Handling Services at Sardar Vallabhbhai Patel International Airport, Ahmedabad for the period from 01.08.2021 to 31.12.2021.

2. In this regard, the tariff determination exercise in respect of M/s GBASPL for Ahmedabad airport is currently under progress. The consultation paper No. 24/2021-22 has already been issued by the Authority on 07.12.2021.

3. Considering the above, the Authority, expects that the Tariff determination exercise for the aforesaid service provider is likely to take some time. Hence, in the interim, the Authority has decided to extend the existing tariffs, applicable as on 31.12.2021, on ad hoc basis, for a further period of two (02) months w.e.f. 01.01.2022 to 28.02.2022, or, till the determination of regular Tariff, whichever is earlier.

**ORDER**

In view of the above, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airport Economic Regulatory Authority of India Act, 2008 hereby orders that:-

- (i) M/s GBASPL, Ahmedabad providing Ground Handling Services at Sardar Vallabhbhai Patel International Airport, Ahmedabad is allowed to levy & collect the existing ad hoc Tariff applicable as on 31.12.2021, on ad hoc basis, for a further period of two (02) months w.e.f. 01.01.2022 to






28.02.2022 or, till determination of regular tariff by AERA for the 3<sup>rd</sup> Control Period, whichever is earlier.

- (ii) The other Terms & Conditions of Order no. 05/2021-22 dated 29.07.2021 shall remain unchanged.
- (iii) The Airport Operator shall ensure compliance of the Order.
