In the matter of Determination of Ad-hoc Tariff for Ground Handling Services to be provided by M/s IndoThai Varanasi Private Limited at Lal Bahadur Shastri International Airport, Varanasi for the period from 11.07.2022 to 31.03.2023.

M/s IndoThai Varanasi Pvt. Ltd. (IVPL) had intimated the Authority vide letter dated 24.09.2021 that M/s IndoThai Airport Management Services Pvt. Ltd. (IAMSPL) had been selected through RFP selection process by Airports Authority of India (AAI) for providing Ground Handling Services at Lal Bahadur Shastri International Airport, Varanasi for a period of 10 years from the Commercial Operations Date ("COD"). In accordance of clause 6 of Letter of Intent (LOI) dated 13.04.2021, a special purpose vehicle (SPV) "IVPL" has been incorporated on 14.05.2021.

- 2. Subsequently, IVPL vide letter dated 18.05.2022 submitted the copy of following documents and requested the Authority for allowing them to charge the same Tariff, as approved for the other Ground Handling Service Provider at Varanasi Airport, namely, Air India Airport Services Limited (AIASL), on ad-hoc basis:
  - i. LOI no. AAI/OPS/GHS/13/B2/2020/155 dated 13.04.2021 issued by AAI.
  - ii. Certificate of Incorporation of SPV "IndoThai Varanasi Private Limited".
  - iii. Security clearance issued by Bureau of Civil Aviation Security.
- 3. Further, M/s IVPL vide email dated 30.06.2022 submitted copy of Concession Agreement dated 20.05.2022 executed between AAI & IVPL and informed the Authority that they propose to commence their commercial operations at Waranas Arroort on 11.07.2022.



- 4. The Authority notes that SPV "IVPL" has obtained the security clearance from Bureau of Civil Aviation Security (BCAS), vide BCAS Order dated 12.05.2022, valid for a period of 5 years from the date of issue of security clearance and has executed concession agreement with Airport Operator.
- 5. The Authority, having examined the request of IVPL, feels that submission of MYTP by the ISP for determination of Tariff for Ground Handling Services at Varanasi Airport will take some time. The Authority, in the interim, decides to allow M/s IndoThai Varanasi Pvt. Ltd., to levy the existing Tariff, as approved for the AIASL, Varanasi (refer Order no. 23/2019-20 dated 14.02.2020 read with Interim Order nos. 67/2020-21 dated 25.03.2021, 18/2021-22 dated 15.09.2021 & 46/2021-22 dated 17.03.2022), on Ad-hoc basis, from 11.07.2022 to 31.03.2023, or, till the determination of regular Ground Handing Tariff, whichever is earlier.

### ORDER

Upon careful consideration of the material available on records, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:

- (i) M/s Indo Thai Varanasi Pvt. Ltd. is allowed to levy, on ad-hoc basis, the existing Tariff for Ground Handling Services, as approved for the other Ground Handling Service Provider, namely, Air India Airport Services Ltd. (AIASL) at Lal Bahadur Shastri International Airport, Varanasi as per Annexure-I w.e.f. 11.07.2022 to 31.03.2023, or, till the determination of regular Tariff in respect of Ground Handing Services for the First Control Period, whichever is earlier.
- (ii) The Authority decides that Tariff for Domestic Non-Scheduled & General Aviation Operations shall not exceed the approved Tariff for relevant Domestic Scheduled Flights for similar class of aircraft(s).
- (iii) Tariff approved, as above, will be the maximum Tariff to be charged from the Users of the Ground Handling Services. No other charges are to be levied over and above the approved Tariff.
- (iv) The Tariff determined herein above is excluding of applicable taxes, if any.
- (v) The Airport Operator shall ensure compliance of the Order.
