**In the matter of Determination of Ad-hoc Tariff for Ground Handling Services to be provided by M/s Global Flight Handling Services (Raipur) Pvt. Ltd., at Swami Vivekananda International Airport, Raipur, for the period from 01.09.2022 to 31.03.2023.**

M/s Global Flight Handling Services (Raipur) Pvt. Ltd. (GFHSR) vide letter dated 03.08.2022 informed the Authority that M/s Global Flight Handling Services Pvt. Ltd. and M/s BAGS Ground Services Co Ltd. have been selected through competitive bidding process by the Airport Operator, namely Airports Authority of India (AAI) for providing Ground Handling Services at Swami Vivekananda International Airport, Raipur. In accordance of clause 5 of Letter of Intent (LOI) dated 11.09.2021, a special purpose vehicle (SPV) "GFHSR" has been incorporated on 20.10.2021. GFHSR proposes to commence their commercial operations at Raipur Airport w.e.f. 01.09.2022.





2. Subsequently, GFHSR vide letter dated 03.08.2022 submitted the copy of following documents and requested the Authority for allowing them to charge the proposed Tariff on ad-hoc basis:

- i. LOI no. AAI/OPS/GHS/16/C/2020/313 dated 11.09.2021 issued by AAI.
- ii. Certificate of Incorporation of SPV "Global Flight Handling Services (Raipur) Pvt. Ltd."
- iii. Security clearance issued by Bureau of Civil Aviation Security.

3. The Authority notes that the SPV "GFHSR" has obtained the security clearance from Bureau of Civil Aviation Security (BCAS), vide BCAS Order dated 30.06.2022, valid for a period of 5 years from the date of issue of security clearance.

4. The Authority notes that GFHSR (SPV) has executed concession agreement with Airport Operator on 15.07.2022 valid for 10 years from the Commercial Operations Date (COD).

5. The Authority, having examined the request of GFHSR feels that submission of MYTP by the new Service Provider in respect of proposed Ground Handling Services at Raipur Airport will take some time. The Authority, in the interim, considering that ISP proposes to commence Ground Handling Services w.e.f. 01.09.2022, has decided to allow M/s Global Flight Handling Services (Raipur) Pvt. Ltd. to levy the ad hoc Tariff, based on the existing Tariff as approved for the Ground Handling Service Provider at Biju Patnaik International Airport, Bhubaneswar, namely, AI Airport Services Ltd. (refer Order no. 23/2019-20 dated 14.02.2020 read with Interim Order nos. 67/2020-21 dated 25.03.2021, 18/2021-22 dated 15.09.2021 & 46/2021-22 dated 17.03.2022), on ad hoc basis, from **01.09.2022 to 31.03.2023**, or, till the determination of regular Ground Handling Tariff, whichever is earlier.

### **ORDER**

Upon careful consideration of the material available on records, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:

- (i) M/s Global Flight Handling Services (Raipur) Pvt. Ltd. is allowed to levy and collect, on ad hoc basis, Tariff for Ground Handling Services at Swami Vivekananda International Airport, Raipur as per **Annexure-I w.e.f. 01.09.2022 to 31.03.2023**, or, till the determination of regular Ground Handling Tariff for the 1<sup>st</sup> Control Period, whichever is earlier.
- (ii) The Tariff to be charged for Ground Handling Services by M/s Global Flight Handling Services (Raipur) Pvt. Ltd for Domestic Non-Scheduled Operations shall not exceed the Tariff approved by the Authority for Domestic Scheduled Operations for 'similar class of aircraft(s)'.
- (iii) M/s Global Flight Handling Services (Raipur) Pvt. Ltd. shall ensure compliance of Standardization of Ground Handling Equipment at Swami Vivekananda International Airport, Raipur, in accordance with the directives issued by Ministry of Civil Aviation vide its letter no. AV-24011/10/2021-AAI-MOCA dated 01.11.2021.



- (iv) Tariff approved, as above, will be the maximum Tariff to be charged from the Users of the Ground Handling Services, excluding of all applicable taxes. No other charges are to be levied over and above the approved Tariff.
- (v) The Airport Operator shall ensure compliance of the Order.
