In the matter of Determination of Ad-hoc Tariff for Ground Handling Services to be provided by M/s Celebi Ground Handling India Private Limited at Sardar Vallabhbhai Patel International Airport, Ahmedabad from Commercial Operations Date (COD) up to 31.03.2023.

ISP's submission:

- M/s Celebi Ground Handling India Private Limited (CGHIPL) vide letter dated 15.09.2021 informed the Authority that a consortium led by "M/s Celebi Airports Services India Pvt. Ltd (CASIPL)" selected, through RFP selection process by Ahmedabad International Airport Limited (Airport Operator), for providing Ground Handling Services at Sardar Vallabhbhai Patel International Airport, Ahmedabad, for a period of 5 years, effective from 01.04.2021.
2. M/s CGHIPL, vide its letter dated 15.09.2022, submitted Multi-Year Tariff Proposal (MYTP) for the period from FY 2022-23 to FY 2025-26 along with a copy of Concession Agreement.
  3. Subsequently, CGHIPL vide email dated 01.12.2022 & 08.12.2022 submitted the copies of following documents:





- a) LoA no. AAIAL/COMM/GH/CELEBI/01 dated 08.03.2021 issued by AAIL.
  - b) Certificate of Incorporation of SPV "Celebi Ground Handling India Private Limited".
  - c) Security clearance issued by Bureau of Civil Aviation Security (BCAS).
4. M/s CGHIPL vide email dated 08.12.2022 requested the Authority to allow them to charge the Tariff as proposed by them for their proposed Ground Handling operations at Ahmedabad airport, on Ad-hoc basis, as issuance of regular Tariff Order in respect of ground handling services at Ahmedabad Airport operations will take some time.

**Authority's examination of the request of M/s CGHIPL**

5. The Authority notes that AIAL (Airport Operator) has issued Letter of Award (LoA) dated 08.03.2021, in favour of M/s Celebi Airports Services India Pvt. Ltd. "M/s Celebi Ground Handling India Private Limited (CGHIPL)", incorporated on 13.10.2018 under the Companies Act, 2013 is acting as a SPV in terms of para ii of the "Letter of Award" dated 8<sup>th</sup> March, 2021.
6. The Authority notes that Concession Agreement dated 30.09.2021 has been executed between the Ahmedabad International Airport Limited (Airport Operator) & CGHIPL (SPV). Further, the Authority notes that as per the clause No. I.1(e) of the Concession Agreement, the operations of the ISP will be effective from the date of Certificate of Readiness issued by the Airport Operator. In this regard, the ISP submitted that the Airport Operator vide email dated 29.11.2022 allowed the ISP to commence their Commercial Operation at Ahmedabad Airport.
7. The Authority notes that in compliance of Ministry of Civil Aviation (MoCA)'s directive vide letter no. AV-24032/184/2022-AAI-MOCA dated 23<sup>rd</sup> September, 2022 relating to provision of Item-wise Charges for Ground Handling Services at Major Airport for Non-Scheduled Operators Permit (NSOP) and General Aviation (GA); M/s CGHIPL vide letter dated 15.09.2022 submitted item-wise charges for Ground Handling Services to be levied at Sardar Vallabhbhai Patel International Airport, Ahmedabad.
8. Subsequently, M/s CGHIPL obtained the requisite security clearance from BCAS, vide BCAS Order dated 21.11.2022 valid for a period of 5 years, from the date of issuance of security clearance.
9. The Authority notes that rates of Ad-hoc Tariff proposed by the ISP are lower than the Tariff approved by the Authority for other Ground Handling Service Provider at Ahmedabad International Airport, namely GSEC Bird Airport Services Pvt. Ltd. (GBASPL). However, the Authority in case of Item wise Tariff rate card noticed that the proposed rates of few services of M/s CGHIPL are higher than the rates approved for other service provider namely M/s GBASPL at the same airport, hence, the Authority decides to consider rates for Item wise Tariff rate card lower of the rates approved for M/s GBASPL and rates proposed by M/s CGHIPL.
10. The Authority, after having examined the request of CGHIPL, notes that completion of regulatory process for determination of regular Tariff for Ground Handling Services for the ISP at Sardar Vallabhbhai Patel International Airport, Ahmedabad, including issuance of Consultation Paper & Tariff Order will take some time.
11. Therefore, the Authority, in the interim, considering that ISP proposes to commence their ground handing operations at Ahmedabad International Airport shortly; decides to allow CGHIPL to levy the Tariff for Ground Handling Services as proposed by the ISP/decided by the Authority, on ad-hoc basis, as per **Annexures (I, II & III)** w.e.f. **COD till 31.03.2023**, or, till the determination of regular Tariff for Ground Handling Services, whichever is earlier.
12. The ISP is advised to inform the Authority, the actual COD for information & records.





## ORDER

Upon careful consideration of the material available on records, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:

- (i) M/s Celebi Ground Handling India Private Limited (CGHIPL) is allowed to levy Tariff for Ground Handling Services at Sardar Vallabhbhai Patel International Airport, Ahmedabad on ad-hoc basis, as per **Annexures (I, II & III)**, w.e.f. **COD to 31.03.2023**, or, till the determination of regular Tariff for ISP in respect of Ground Handling Services for the Third Control Period, whichever is earlier.
- (ii) The Authority decides that Tariff for Domestic Non-Scheduled & General Aviation, including Item-wise Charges, shall not exceed the approved Tariff(s) for relevant Domestic Scheduled Flights for similar class of aircraft(s).
- (iii) Tariff approved, hereinunder, will be the maximum Tariff to be charged from the Users of the Ground Handling Services. No other charge(s) is to be levied over and above the approved Tariff.
- (iv) The Authority decides that in case of payment in foreign currency, the RBI conversion rate as on the last day of the previous month will be applicable for the first fortnight and rate as on 15<sup>th</sup> of the month will be applicable for the second fortnight.
- (v) M/s CGHIPL shall at the end of each tariff year submit Annual Compliance Statement (ACS), including annual audited accounts, as per AERA CGF Guidelines, 2011 (clause 11.4).
- (vi) M/s CGHIPL shall ensure compliance of Standardization of Ground Handling Equipment at Ahmedabad International Airport in accordance with the directives issued by Ministry of Civil Aviation vide its letter no. AV-24011/10/2021-AAI-MOCA dated 27.10.2022.
- (vii) The Tariff determined herein above is excluding of applicable taxes, if any.
- (viii) The Airport Operator shall ensure compliance of the Order.
