In the matter of determination of aeronautical tariff for Sardar Vallabhbhai Patel International Airport, Ahmedabad (AMD) for the Third Control Period (01.04.2021 to 31.03.2026)

1. Airports Economic Regulatory Authority of India ("AERA" or "Authority") vide Order No. 40/2022-23 dated 18<sup>th</sup> January 2023 had determined the aeronautical tariff for SVPIA, Ahmedabad for the Third Control Period (01.04.2021 to 31.03.2026).
2. In the Tariff Rate Card under Annexure-I, the Authority had approved domestic Landing and Parking charges for the flights having weight of an aircraft up to 100 MT.
3. Subsequent to the issue of Order, AIAL, vide its letter dated 27<sup>th</sup> February 2023, has informed that certain domestic flights are operated on aircraft with weight of an aircraft above 100 MT and submitted the following for the consideration of the Authority:

*"The Landing and Parking rates for domestic sector as prescribed in the tariff card is applicable for all type of domestic aircrafts whether upto 100 MT or more than 100 MT"*

4. Based on its examination, the Authority is of the view that this insertion will bring more clarity regarding the applicability of Landing and Parking charges in case of Domestic flights as approved for each tariff year of the Control Period. The Authority, therefore, decides to consider the following as an insertion under Annexure I-A(a)(Notes) as point vi and Annexure I-A(b)(Notes) as point viii of the Order No. 40/2022-23 for the Third Control Period:

*"Domestic Charges as prescribed in the tariff card is applicable for all type of domestic sector aircraft i.e., upto 100 MT or above 100 MT."*

**ORDER**



The Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, and the facts and clarifications placed on record before the Authority, decides and orders to insert the following under Annexure-I(a)(Notes) as point vi in case of Landing Charges and under Annexure-I(b)(Notes) as point viii in case of Parking Charges respectively in Order No. 40/2022-23:



“Domestic Charges as prescribed in the tariff card is applicable for all type of domestic sector aircraft i.e., upto 100 MT or above 100 MT.”

6. The other terms and conditions of the Order No. 40/2022-23 dated 18<sup>th</sup> January 2023 shall remain unchanged.
