- Sub: In the matter of Ad-hoc Tariff for Ground Handling Services to be provided by M/s Celebi Ground Handling Services Chennai Pvt. Ltd. (CGHSC) at Chennai International Airport w.e.f. Commercial Operations Date (COD) till 30.09.2023.

M/s Celebi Ground Handling Services Chennai Pvt. Ltd. (CGHSC) vide letter dated 04.04.2023 requested the Authority to approve Ad-hoc Tariff for their proposed Ground Handling Services (GHS) at the Chennai airport, till the determination of regular Tariff for Ground Handling Services by the Authority. M/s CGHSC informed the Authority that they have been selected through competitive bidding process by the Airport Operator, namely Airport Authority of India (AAI), for providing Ground Handling Services at Chennai International Airport.

- 2. M/s CGHSC, subsequently submitted the copies of following documents:
 - (i) LOI no. AAI/OP-12018/8/2022-Operations dated 18.11.2022 issued by AAI.
 - (ii) Security clearance issued by Bureau of Civil Aviation Security.

(iii) License Agreement execute between the AAI & CGHSC (SPV created by M/s CASIPL).

Authority's examination of the request of M/s CGHSC

3. The Authority notes that AAI (Airport Operator) has issued a Letter of Award (LoA) dated 18.11.2022, in favour of M/s Celebi Airports Services India Pvt. Ltd.(CASIPL). Pursuant to issuance of LoA, M/s CASIPL formed a wholly owned Special Purpose Vehicle (SPV) namely "M/s Celebi Ground Handling Services Chennai Pvt. Ltd. (CGHSC)" in terms of para 5 of the "Letter of Award" dated 18th November, 2022. The abovesaid SPV was incorporated on 02.12.2022 under the Companies Act, 2013.

4. The Authority notes that the CGHSC has obtained the requisite security clearance from Bureau of Civil Aviation Security (BCAS) vide BCAS Order dated 21.03.2023, valid for a period of 5 years, from the date of issue of security clearance.

5. The Authority also observes that in compliance of Ministry of Civil Aviation (MoCA)'s directive vide letter no. AV-24032/184/2022-AAI-MOCA dated 23rd September, 2022 relating to provision of Item-wise Charges for Ground Handling Services at Major Airport for Non-Scheduled Operators Permit (NSOP) and General Aviation (GA); M/s CGHSC has submitted item-wise charges for various Ground Handling Services.

6. Presently, M/s AI Airport Services Limited (AIASL) is the only ISP rendering Ground Handling Services at the Chennai airport. The Authority, for the purpose of ad-hoc tariff, decided to analyze and compare the tariff rates proposed by the ISP with the tariff rates approved by the Authority for AIASL, Chennai. However, it is observed that Tariff structure of AIASL for its ground handling services at Chennai airport is not comparable with the structure of the Tariff Rate Card proposed by the ISP.

7. Hence, the Authority, has analyzed / compared the Tariff rates proposed by CGHSC with the approved Tariffs of other ISPs (Air India SATS [AISATS] & Celebi Airport Services India Pvt. Ltd [CASIPL]) providing similar services at Bengaluru Airport. Accordingly, based on the comparative analysis of Tariffs of above referred ISPs, the Authority decides to adopt the minimum Tariff rate for each category of Aircraft Codes for the CGHSC at Chennai airport, as an interim arrangement, as per **Annexure-I, II & III**), w.e.f. **Commercial Operations Date** ("**COD**") up to 30.09.2023, or, till the determination of regular Tariff for the Ground Handing Services for the ISP, whichever is earlier.

<u>ORDER</u>

Upon careful consideration of the material available on records, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:

- (i) M/s Celebi Ground Handling Services Chennai Pvt. Ltd., is allowed to levy and collect, on ad-hoc basis, the Tariff for Ground Handling Services at Chennai International Airport, Chennai as per Annexure-I, II & III w.e.f. COD up to 30.09.2023, or, till the determination of regular Tariff for Ground Handling Services for the ISP, whichever is earlier.
- (ii) The Authority decides that Tariff(s) for Domestic Non-Scheduled & General Aviation Operations shall not exceed the approved Tariffs for relevant Domestic Scheduled Flights for similar class of aircraft(s).
- (iii) Tariff approved, as above, shall be the maximum Tariffs to be charged from the Users of the Ground Handling Services. No other charges are to be levied over and above the approved Tariffs.

- (iv) M/s Celebi Ground Handling Services Chennai Pvt. Ltd. shall ensure compliance of Standardization of Ground Handling Equipment at Chennai International Airport in accordance with the directives issued by Ministry of Civil Aviation vide its letter no. AV-24011/10/2021-AAI-MOCA dated 27.10.2022.
- (v) The Tariff approved hereinunder is excluding of applicable taxes, if any.
- (vi) M/s Celebi Ground Handling Services Chennai Pvt. Ltd. (CGHSC) shall maintain the separate accounts for its Ground Handling Operations at Chennai International Airport and at the end of each tariff year will submit Annual Compliance Statement (ACS), including annual audited accounts, as per AERA CGF Guidelines, 2011 (clause 11.4).
- (vii) The Airport Operator shall ensure compliance of this Order.
