In the matter of Determination of Ad-hoc Tariff for Cargo Handling Services to be provided by M/s Menzies Aviation (Bengaluru) Private Limited (MABPL) at Kempegowda International Airport (KIA), Bengaluru from Commercial Operations Date (COD) i.e. 24.05.2023 up to 30.09.2023.

ISP's submission:

 Menzies Aviation Limited is one of the successful bidders selected by Bangalore International Airport Limited (BIAL) for providing Cargo Handling Services at Kempegowda International Airport (KIA), Bengaluru, apart from WFS (Bengaluru) Private Limited. As per the Joint Venture Agreement between the successful bidder (i.e. Menzies Aviation Limited) and the Airport Operator (BIAL), the successful bidder and the BIAL shall enter into the Joint Venture to provide the Cargo Handling Services at the KIA, Bengaluru. Accordingly, Menzies Aviation (Bengaluru) Private Limited hereinafter referred to as "MABPL", a Joint Venture Company (JVC) has been formed by Menzies Aviation Limited & BIAL and incorporated on 5th September, 2022 under the Indian Companies Act, 2013.

- 2. M/s MABPL, vide its letter dated 09.03.2023, submitted Multi-Year Tariff Proposal (MYTP) to the Authority for the period from FY 2023-24 to FY 2027-28 along with the following documents:
 - a) Annual Tariff Proposal (ATP) Forms as per AERA guidelines.
 - b) Service Provider Right Holder (SPRH) Agreement.
 - c) Minutes of the Stakeholders' meeting.
 - d) Business Plan.
- 3. Subsequently, M/s MABPL vide letter dated 13.04.2023, requested the Authority to approve the Adhoc Tariff rates in respect of their proposed Domestic and International Cargo Handling Services at Bengaluru Airport. The ISP, in its proposal, has proposed 35% & 15% increase in domestic & international tariff rates, over the prevailing tariff rates applicable to incumbent cargo terminal operator i.e. Menzies Aviation Bobba (Bengaluru) Private Limited (MABBPL), Bengaluru airport, till the determination of regular tariff.
- 4. MABPL (new service provider) submitted following major reasons for the increase proposed in the Ad-hoc Tariff Rates, as compared to tariff applicable to incumbent operator:
 - a. Tariff rates for MABBPL (incumbent cargo terminal operator) for its Cargo Handling Services at KIA, Bengaluru were last revised by the Authority vide Order no. 14/2013-14 dated 10th June, 2013.
 - b. Estimated Capital expenditure of INR 225.70 Crores proposed to be incurred during First Control Period.
 - c. Operational & Maintenance (O&M) expenditure of Rs 1065.00 Crores approx. estimated for the First Control Period.

Authority's examination on the request of M/s MABPL:

- 5. The Authority notes that Menzies Aviation Limited has been awarded a concession to provide Domestic and International Cargo Handling Services at Kempegowda International Airport (KIA), Bengaluru by the Airport Operator (BIAL). Pursuant to above, a joint venture company i.e. "MABPL" was formed by Menzies Aviation Limited and BIAL. The newly formed company has been incorporated under the Indian Companies Act, 2013 on 5th September, 2022.
- 6. Subsequently, Service Provider Right Holder (SPRH) Agreement (tripartite agreement) was executed between BIAL, Menzies Aviation Limited and MABPL on 26th December, 2022. As per SPRH Agreement, the concession term is Fifteen (15) years from the date of handover of Existing Cargo Terminal-1, which may be further extended for a period up to Seven (7) years, at the discretion of the BIAL.
- 7. The shareholding structure of the MABPL(JVC) is as below:

- 8. As per clause 2 of SPRH Agreement, MABPL is entrusted with the rights to:
 - i. Design, build, finance, develop, undertake, refurbishment activities of the Existing Cargo Terminal-1 as prescribed by BIAL.
 - ii. Design, build, finance, develop, operate, manage, maintain and transfer the new Domestic Cargo Terminal.
- 9. The Authority notes that MABPL has obtained the security clearance from Bureau of Civil Aviation (BCAS) vide its Order dated 20th April, 2023. As per the BCAS Order "The security clearance shall be valid for a period of five years from the date of issue of security clearance or the period of validity of contract with the airport operator, whichever is earlier."
- 10. The Authority notes that MABPL has proposed 35% & 15% increase in Tariffs (Ad-hoc Tariff) for Domestic & International Cargo Handling Services respectively, over the existing tariff rates approved by the Authority for the incumbent Cargo Service Provider i.e. Menzies Aviation Bobba (Bengaluru) Private Limited (MABBPL) at Bangaluru Airport. In addition, MABPL has also proposed ad-hoc tariff rates for few additional services, which are not part of the MABBPL's (incumbent Cargo Terminal Operator) Tariff Rate Card. MABPL vide mail dated 04.05.2023 has submitted the justifications/ reasons in respect of following major additional services:

- 11. MABPL, vide email dated 02.05.2023, also submitted separate Tariff Rates for Built up Pallets (BUPs) pertaining to AFS Cargo. The Authority observes that ISP has proposed 30% lower tariff rates for BUPs (TSP charges) as compared to charges proposes in respect of normal cargo, for export and import cargo handling services.
- 12. As regard to proposed increase in tariff rates for domestic & international cargo handling services sought by the ISP as indicated at para 10 above, the Authority will examine the MYTP submitted by the ISP and other relevant aspects of the proposal, including CAPEX, OPEX, Cargo Volumes and other regulatory building blocks etc., in detail while finalizing consultation paper.
- 13. Meanwhile, for the purpose of finalizing ad-hoc tariff in respect of the MABPL, the Authority has compared the ad-hoc tariff rates proposed by the ISP with the prevailing tariffs in respect of other two

incumbent cargo terminal operators at Bengaluru Airport, namely Menzies Aviation Bobba (Bengaluru) Pvt. Ltd. & Air India SATS Airport Services Private Limited (AISATS) as approved by the AERA vide Order no. 41/2018-19 dated 25th February, 2019 & 40/2017-18 dated 01.03.2018 respectively and which have been extended for the further period up to 30.09.2023, on interim basis, as per the AERA orders issued from time to time.

Based on the comparative analysis of tariffs pertaining to two incumbent operators and tariff as proposed by the ISP, the Authority decides to consider the lowest tariff rates for various cargo handling services proposed by the ISP at KIA, Bengaluru, on ad-hoc basis. Further, in case of additional cargo handling services, which are not part of the tariff rate cards of the incumbent operators, the Authority has compared the tariff proposed by the ISP for such additional services with the rates prevailing at other major airports for such similar services and decides to consider lowest tariff for additional services based on the comparative analysis.

14. The Authority notes that completion of regulatory process for determination of regular Tariff for Cargo Handling Services for the ISP at Bengaluru airport, including issuance of Consultation Paper & Tariff Order, will take some time. Further, considering the commencement of proposed commercial operations by the ISP at Bengaluru airport from 24.05.2023, the Authority, as an interim measure, decides to allow MABPL to levy ad-hoc Tariff for the Cargo Handling Services to be provided by the ISP at Bengaluru airport, as per Annexures-I w.e.f. 24.05.2023 up to 30.09.2023, or, till the determination of regular Tariff for the ISP, whichever is earlier.

ORDER

Upon careful consideration of the material available on records, the Authority, in exercise of powers conferred by Section 13(1) (a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:

- (i) M/s Menzies Aviation (Bengaluru) Private Limited is allowed to levy and collect Tariff for Cargo Handling Services at Kempegowda International Airport, Bengaluru, on ad-hoc basis, as per Annexures-I w.e.f. 24.05.2023 to 30.09.2023, or, till the determination of regular Tariff for ISP in respect of its Cargo Handling Services for the First Control Period, whichever is earlier.
- (ii) This order shall be effective subject to receipt of all requisite regulatory and statutory approvals, before the commencement of commercial operations by the ISP at Kempegowda International Airport (KIA), Bengaluru.
- (iii) Tariff determined, hereinunder, shall be maximum Tariffs to be charged. No other charge(s) is to be levied over and above the approved Tariffs.
