विषय : मौजूदा टैरिफ की वसूली 31.03.2024 तक जारी रखने के लिए अंतरिम व्यवस्था।
Subject: Interim arrangement to levy the existing tariffs to continue till
31.03.2024.

AERA, vide Order No. 41/2022-23 dated 22nd March, 2023 inter-alia, allowed the following airports/airport operators to levy tariffs, on interim basis, for a further period of 06 (six) months w.e.f. 01.04.2023 to 30.09.2023, or, till the determination of regular tariff for their respective control periods, whichever is earlier:

1.2 Further, vide addendum dated 07.06.2023 to Order No. 41/2022-23 dated 22.03.2023, AERA issued revised aeronautical charges, in respect of Shirdi Airport, on



interim basis, w.e.f. 16.06.2023 to 30.09.2023 or till the determination of regular tariffs, whichever is earlier.

2. The Authority reviewed the position in respect of determination of regular tariffs in respect of above airports and inclusion of two more AAI airports Indore and Coimbatore (as Major Airports) and observed as under:

- (i) Tariff Order for Lucknow Airport & Srinagar Airport has already been issued.
- (ii) Ad-hoc tariff in respect of Mopa Goa airport has been already extended till 31.12.2023, vide addendum dated 11.09.2023 to AERA Order No19/2022-23 dated 26.08.2022.
- (iii) Multi Year Tariff Proposals in respect of Jaipur, Guwahati, Trivandrum, Kannur, Bhubaneswar and Shirdi Airports are under examination and the completion of process is likely to take some more time.
- (iv) Multi Year Tariff Proposals in respect of Patna, Indore and Coimbatore airports are yet to be received from AAI.

3. In view of above, it is evident that the final determination of tariff for aeronautical services in respect of Jaipur, Guwahati, Trivandrum, Kannur, Patna, Bhubaneswar, Indore, Coimbatore and Shirdi Airports is likely to take more time and accordingly, the Authority decides as under:

- (a) To extend the existing tariff, as applicable on 30.09.2023, on interim basis, for a further period of 06 (six) months w.e.f. 01.10.2023 to 31.03.2024 or till the determination of regular tariffs for the relevant Control Period, whichever is earlier, in respect of the airports/airport operators given in table 1 below:

(b) Indore and Coimbatore Airports are also allowed to levy the aeronautical tariffs, applicable as on 31.03.2023, for six (06) months w.e.f. 01.10.2023 to 31.03.2024, or till the determination of regular tariffs for the relevant control period, whichever is earlier.

ORDER

In view of the above, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that: -

- (i) The **Airport Operators (listed at Sr. No. 1 to 7 of Table-I above)** are allowed to levy the existing tariff, applicable as on 30.09.2023, on interim basis, for a further period of 06 (six) months w.e.f. 01.04.2023 to 30.09.2023, or, till the determination of regular tariff for their respective Control Period, whichever is earlier.
- (ii) The Airport Operator (AAI) of Indore and Coimbatore Airports are allowed to levy the aeronautical tariffs, applicable as on 31.03.2023, for six (06) months w.e.f. 01.10.2023 to 31.03.2024, or till the determination of regular tariffs for the relevant control period, whichever is earlier.
- (iii) The Airport Operators shall ensure compliance of the Order.

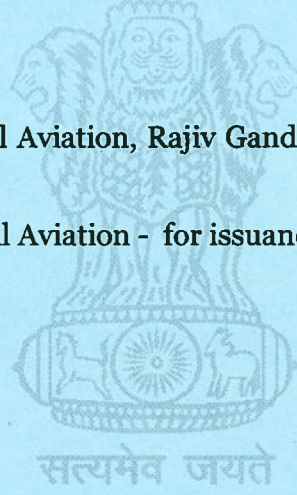
