Sub.: In the matter of levy of Development Fee (DF) for Project Work at Chhatrapati Shivaji Maharaj International Airport, Mumbai – reg.

AERA, vide Order No. 09/2023-24 dated 14.06.2023, allowed Chhatrapati Shivaji Maharaj International Airport, Mumbai to continue the levy of DF @ Rs. 100/- per domestic embarking passenger and @ Rs. 600/- per international embarking passenger for tickets issued till 31.12.2023. This Order was issued, inter-alia, based on the inputs provided by AAI, who are the custodian for management of DF (as outlined in DF Rule 2011) and duly audited by the Independent Auditor appointed by AAI.

2. However, Hon'ble Telecom Disputes Settlement & Appellate Tribunal, vide its Interim Order dated 19.12.2023, passed in the AERA Appeal No. 4/2023, has inter-alia, ordered as under:

"We, therefore, permit this appellant to continue to levy DF @•Rs. 100 per Domestic Embarking Passenger and Rs. 600 per International Embarking Passenger till 29.2.2024 on the condition that this amount shall be deposited in an Escrow Account and the utilization and the withdrawl of this amount shall be as per the permission granted by AAI and it will be as per "The Rules, 2011". Moreover, this appellant shall maintain accurately the accounts for the DF

collected through the Airlines for the period running from 1.1.2024 to 29.2.2024 and this account shall be presented by this appellant before AAI."

- 3. In compliance of above-mentioned Interim Order of Hon'ble TDSAT, the period for collection of DF @ Rs. 100/- per domestic embarking passenger and @ Rs. 600/- per international embarking passenger at Chhatrapati Shivaji Maharaj International Airport, Mumbai stands extended till 29.02.2024.
- 4. All other terms & conditions of AERA Order 09/2023-24 dated 14.06.2023 shall remain unchanged.
