Subject: Addendum to Order no. 20/2023-24 dated 27.09.2023 regarding extension of interim arrangement to levy the existing tariffs for further period up to 31.03.2024 in respect of the Express Industry Council of India providing Courier/Express Cargo Services at Bengaluru Airport.

M/s Express Industry Council of India (EICI) providing Courier/Express Cargo Services at Kempegowda International Airport (KIA), Bengaluru vide letter dated 21.09.2023 requested the Authority to allow interim arrangement to levy the existing tariff for the period up to 31.01.2024, as they were expecting to cease their operation at Bengaluru Airport by the end of January, 2024.

- 2. Accordingly, the Authority vide its Order no.20/2023-24 dated 27.09.2023 approved, on ad hoc basis, to levy the existing tariff, applicable as on 30.09.2023 up to 31.01.2024 in respect of M/s EICI for providing Courier/Express Cargo Services at Bangaluru Airport.
- 3. Subsequently, M/s EICI vide letter no. EICI/MEMO/161 dated 15.01.2024 informed the Authority that M/s Air India SATS, the prospective operator interested in taking over Common User Express Terminal operations at Bengaluru Airport has applied for regulatory permissions and are awaiting approvals from the concerned Authorities.
- 4. In views of the above, the ISP requested the Authority to extend the interim Tariff (as on 31.01.2024) for the further period up to 31.03.2024

5. Considering the above, the Authority decides to allow Express Industry Council of India (EICI), providing Courier/Express Cargo Services at Kempegowda International Airport (KIA), Bengaluru, to levy the existing Tariff (applicable as on 31.01.2024) for a further period of two months i.e. from 01.02.2024 to 31.03.2024.
