Subject: Interim arrangement to levy the existing tariffs to continue till 30.09.2024.

AERA, vide Order No. 19/2023-24 dated 20th September, 2023 inter-alia, allowed the following airports/airport operators to levy tariffs, on interim basis, for a further period of 06 (six) months w.e.f. 01.10.2023 to 31.03.2024, or, till the determination of regular tariff for their respective control periods, whichever is earlier:

2. The Authority reviewed the position in respect of determination of regular tariffs in respect of above airports and observed as under:



- (i) Tariff Order for Kannur Airport, Patna Airport & Bhubaneswar Airport has already been issued.
- (ii) Multi Year Tariff Proposals in respect of Jaipur, Guwahati, Trivandrum, Indore, Coimbatore and Shirdi Airports are under examination and the completion of process is likely to take some more time.
- (iii) Multi Year Tariff Proposals in respect of Delhi, Mumbai, Amritsar, and Varanasi airports are yet to be received from the Airport Operators. Previous Control Period of these four airports is expiring on 31st March, 2024.
- 3. In view of above, it is evident that the final determination of tariff for aeronautical services in respect of Jaipur, Guwahati, Trivandrum, Indore, Coimbatore, Shirdi, Delhi, Mumbai, Amritsar, and Varanasi Airports is likely to take more time and accordingly, the Authority decides as under:

To extend the existing tariff, as applicable as on 31.03.2024, on interim basis, for a further period of o6 (six) months w.e.f. 01.04.2024 to 30.09.2024 or till the determination of regular tariffs for the relevant Control Period, whichever is earlier, in respect of the airports/airport operators given in table 1 below:

ORDER

In view of the above, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:



- (i) The Airport Operators (listed at Sr. No. 1 to 10 of Table-I above) are allowed to levy the existing tariff, applicable as on 31.03.2024, on interim basis, for a further period of 06 (six) months w.e.f. 01.04.2024 to 30.09.2024, or, till the determination of regular tariff for their respective Control Period, whichever is earlier.
- (ii) The Airport Operators shall ensure compliance of the Order.
