Subject: Interim arrangement to levy the existing tariffs to continue till 30.06.2025/30.09.2025.

AERA, vide Order No. 09/2024-25 dated 24th September, 2024 inter-alia, allowed the following airports/airport operators to levy tariffs, on interim basis, for a period of 06 (six) months w.e.f. 01.10.2024 to 31.03.2025, or, till the determination of regular tariff for their respective control periods, whichever is earlier:

- 2. The Authority reviewed the position in respect of determination of regular tariffs in respect of above airports and observed as under:
 - i. Tariff Order for 2nd Control Period of Indore, Varanasi and Amritsar Airport has been issued.
 - ii. Consultation Paper for Delhi & Mumbai Airport has been issued and the process of finalization and issuance of Tariff Order is in advanced stage.
 - iii. MYTP of Port Blair Airport is under examination.

- 3. Further, Dehradun Airport has recently been declared as a Major Airport, based on the designated capacity of more than 3.5 MPPA as defined under Section 2(i) of AERA Act 2008. MYTP has been received from AAI.
- 4. Moreover, Previous Control Period Tariff of Raipur & Trichy airports are expiring on 31st March, 2025 and Multi Year Tariff Proposals (MYTP) in respect of these two Airports of AAI is yet to be received from the Airport Operators.
- 5. In view of the above, it is evident that:
 - a. The process of final determination of tariff for aeronautical services in respect of Delhi & Mumbai Airports is in advanced stage and likely to be concluded in the coming months.
 - b. MYTP in respect of Port Blair Airport is under examination.
 - c. Tariff determination process in respect of Raipur and Trichy airport will commence after the receipt of MYTP from AAI, which is still awaited.

Accordingly, the Authority decides to extend the existing tariff, as applicable as on 31.03.2025, for Delhi & Mumbai Airports for a period of 3 months w.e.f. 01.04.2025 to 30.06.2025 and for Port Blair, Dehradun, Raipur, Trichy Airports for a period of 6 months w.e.f. 01.04.2025 to 30.09.2025 in respect of the airports/airport operators as given in Table 2 below:

ORDER

Upon careful consideration of the material available on records, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:

(i) The Airport Operators listed at Sr. No. 1 to 2 of Table-2 above are allowed to levy the existing tariff, applicable as on 31.03.2025, on interim basis, for a further period of 03 (three) months w.e.f. 01.04.2025 to 30.06.2025 or till the determination of regular tariff for their respective Control Period, whichever is earlier.

- (ii) The Airport Operators listed at Sr. No. 3 to 6 of Table-2 above are allowed to levy the existing tariff, applicable as on 31.03.2025, on interim basis, for a further period of 06 (six) months w.e.f. 01.04.2025 to 30.09.2025 or till the determination of regular tariff for their respective Control Period, whichever is earlier.
- (iii) Airport Operator listed at Sr. No. 5 to 6 of Table-2 above is advised to submit the MYTP in a timely manner as per the Authority's Guidelines.
- (iv) The Airport Operators shall ensure compliance of the Order.
