**Subject: In the matter of Aeronautical Tariff at Major Airports- Reduction in Landing & Parking Charges-reg.**

The Central Government, vide its letter No. F.No. AV-24011/03(I)/2026-AD dated 07.04.2026, has issued directions to the Airports Economic Regulatory Authority (AERA) under Section 42 of the AERA Act, 2008, to reduce landing and parking charges by 25% at all major airports on domestic flights for a period of 3 months, in view of the ongoing West Asia Crisis.

The Authority deliberated in detail on 07.04.2026 on the aforesaid directions of Central Government as a matter of policy. While doing so, it also took into consideration the provisions of Section 13(2) of the AERA Act, which empower the Authority to amend tariffs from time to time within the control period of 5 years in the public interest. After due consideration, the Authority has decided to implement the directions issued by the Government.

Accordingly, the following measures shall come into effect:

- Landing and parking charges at all major airports shall be reduced by 25% from the prevailing tariff. This reduction shall take effect immediately and will be applicable on all domestic flights for a period of 3 months.
- The applicability of the above decision shall be reviewed prior to the completion of the 3 month period.
- Any under-recovery in the Aggregate Revenue Requirement (ARR), will be trued up during the tariff determination for the next control period.

In view of the above, the Authority hereby decides to implement the directions of the Government in the public interest.



**ORDER: -**

The Authority, in exercise of powers conferred by Section 13(1)(a) read with 13(2) of the Airports Economic Regulatory Authority of India Act, 2008, orders that:

- i. Landing and parking charges (part of aeronautical tariff) at all Major airports shall be reduced by 25% from the prevailing tariff.
- ii. This reduction comes into immediate effect and will be applicable on all domestic flights for a period of 03 months.
- iii. The decision shall be reviewed prior to completion of 3 months period.
- iv. Any under-recovery from the Aggregate Revenue Requirement, will be trued-up during the tariff determination of next Control Period.
