Annual Tariff Order for 4th tariff year of the first control period

This Authority, vide Direction No. 04/2010-11 dated 10.01.2011, had issued the Guidelines [The Airports Economic Regulatory Authority of India (Terms and Conditions for Determination of Tariff for Services provided for Cargo Facility, Ground Handling and Supply of Fuel to the Aircraft), Guidelines, 2011] prescribing procedures, terms and conditions for determination of tariff for the above mentioned regulated services being provided by Independent Service Provider(s). As per the Guidelines, the service providers are required to submit Multi Year Tariff Proposal (MYTP) for the five-year control period and Annual Tariff Proposal (ATP) for individual tariff years of the Control Period.

- 2. Accordingly, M/s Cambata Aviation Private Limited (Cambata) submitted their MYTP for first control period commencing 01.04.2011 in respect of ground handling services provided at IGI Airport, New Delhi. The Authority issued Multi Year Tariff Order (MYTO) No. 35/2011-12 dated 14.03.2012 vide which it ordered that the Authority shall adopt a "light touch approach" for the ground handling service provided by Cambata at IGI Airport, New Delhi for the first control period starting w.e.f. 01.04.2011. The Authority had also determined the tariff(s) for the first (FY 2011-12) and second (FY 2012-13) tariff years of the first control period vide Order No. 39/2012-13 dated 19.02.2013. Later, vide Order No. 23/2013-14 dated 28.06.2013, the tariff(s) for third tariff year were also determined.
- 3. M/s Cambata, vide letter no. nil dated 20.03.2014, submitted its Annual Tariff Proposal (ATP) for fourth tariff year for its ground handling operations at IGI Airport, New Delhi and stated the tariff given therein are inclusive of the royalties payable to Airport Operator.
- 4. Accordingly, a Consultation Paper No. 13/2014-15 was issued on 12.11.2014 with 14 days response time. The last date of receipt of comments was 26.11.2014. The Authority noted that the rates mentioned in the ATP (in rupees) are within the ceiling rates for ground handling rates notified by DIAL vide letter dated 20.04.2012. Further, DIAL vide letter dated 10.09.2014, jurnished a copy of concession agreement with

Cambata wherein it is stated that the back office function undertaken by the agency for the carriers are covered under Annexure B (Clause No 4.4 – Representation Services) of the DGCA.

5. In response to the proposal contained in the Consultation Paper, no comments have been received from any stakeholders.

ORDER

- 6. Upon careful consideration of material available on record, the Authority, in exercise of powers conferred by Section 13 (1) (a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:
 - (i) The Annual Tariff Proposal for the fourth tariff year (w.e.f. 01.04.2014 to 31.03.2015) of the first control period submitted by M/s Cambata Aviation Private Limited (Cambata) for ground handling services at IGI Airport, New Delhi are determined to be as at **Annexure I.**
