Determination of tariff for the fifth (2015-16) tariff year of the first control period.

This Authority, vide Direction No. 04/2010-11 dated 10.01.2011, had issued the Guidelines [The Airports Economic Regulatory Authority of India (Terms and Conditions for Determination of Tariff for Services provided for Cargo Facility, Ground Handling and Supply of Fuel to the Aircraft), Guidelines, 2011] prescribing procedures, terms and conditions for determination of tariff for the above mentioned regulated services being provided by Independent Service Provider(s). As per the Guidelines, the service providers are required to submit Multi Year Tariff Proposal (MYTP) for the five year control period and Annual Tariff Proposal (ATP) for individual tariff years of the Control Period.

- 2. Accordingly, the Authority had considered the Multi Year Tariff Proposal (MYTP) submitted by Air India SATS Airport Services Pvt. Ltd. (AISATS) for the first control period commencing 01.04.2011 in respect of Ground Handling Services at IGI Airport, New Delhi. After due stakeholder consultation, the Authority issued Multi Year Tariff Order (MYTO) No 36/2013-14 dated 12.12.2013 vide which the Authority ordered that ground handling service provided by AISATS is "material but competitive" and hence tariff shall be determined under "Light Touch Approach" for the first control period. Along with the MYTO, the Authority also determined the tariff for the first, second, third and fourth tariff years.
- 3. AISATS, vide letter dated 05.06.2015 submitted Annual Tariff Proposal (ATP) for the fifth tariff year, but the Annual Compliance Statement (ACS) of the previous tariff year i.e. FY 2014-15 is yet to be submitted by the service provider.
- 4. The Authority, vide letter dated 17.06.2015 requested AISATS to furnish the justification for increase proposed in the 5th tariff year by 25.06.2015 failing which it was informed that the Authority shall approve continuation of existing tariffs upto 31.03.2016 i.e. for the remaining period of 1st Control Period. However, there has been no response from AISATS till date.

- 5. The Authority noted the following:
  - (i) AISATS has not submitted the proof of stakeholder consultation and justification for increase in domestic tariff for the fifth tariff year.
  - (ii) Less than one year is left for completion of the 1st Control Period, which is set to expire on 31.03.2016 and process for determination of tariff involving stakeholder consultation will take approx. 2-3 months and thus, benefit of revised tariff may be available for less than 6 months from the date of order.

#### **ORDER**

- 6. Upon careful consideration of material available on record, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:
  - (i) Air India SATS Services Pvt. Ltd. would continue to levy tariffs in respect of Ground Handling Services at IGI Airport, New Delhi for the remaining period of the current control period at the same level as was approved vide Authority's Order No. 36/2013-14 dated 12.12.2013 for the fourth tariff year (Annexure I).
  - (ii) Air India SATS Service Pvt. Ltd. should submit the MYTP and ATP for the 2<sup>nd</sup> Control Period well in time as per the Guidelines after incorporating the actual financials of 2014-2015.
