Determination of tariff for the fifth (2015-16) tariff year of the first control period.

This Authority, vide Direction No. 04/2010-11 dated 10.01.2011, had issued the Guidelines [The Airports Economic Regulatory Authority of India (Terms and Conditions for Determination of Tariff for Services provided for Cargo Facility, Ground Handling and Supply of Fuel to the Aircraft), Guidelines, 2011] prescribing procedures, terms and conditions for determination of tariff for the above mentioned regulated services being provided by Independent Service Provider(s). As per the Guidelines, the service providers are required to submit Multi Year Tariff Proposal (MYTP) for the five year control period and Annual Tariff Proposal (ATP) for individual tariff years of the Control Period.

2. Accordingly, the Authority had considered the Multi Year Tariff Proposal (MYTP), submitted by Delhi Cargo Service Centre Pvt. Ltd., (DCSC) for the first control period, commencing w.e.f. 01.04.2011, in respect of determination of tariff for cargo handling services being provided at IGI Airport, New Delhi and after due stakeholder Consultation issued Multi Year Tariff Order (MYTO) No. 13/2011-12 dated 07.10.2011, ordering that the cargo handling service rendered by DCSC at IGI Airport, New Delhi is "material but competitive" and hence the Authority adopts "light touch approach" for determination of tariff for the first control period. Pursuant to issue of above, the Authority considered the Annual Tariff Proposal (ATP) for the first & second tariff years vide Order No. 05/2012-13 dated 21.05.2015, for third tariff year vide Order No. 30/2013-14 dated 31.07.2013 and fourth tariff year vide Order No. 18/2014-15 dated 06.02.2015 respectively.

3.1 Thereafter DCSC vide letter no. nil dated 19.03.2015 submitted the Annual Tariff Proposal (ATP) for the fifth tariff year (2015-16) of the first control period along with the relevant documents as per the Authority's Guidelines. DCSC also submitted their dully filled Annual Compliance Statement for tariff years 2011-12, 2012-13, 2013-14 and 2014-15 respectively.



3.2 DCSC submitted that they have proposed the revision in city side tariff for international cargo and no change is proposed in domestic cargo handling for both city side and air side from previous year approved tariff. The changes proposed in the Tariff are (i) Revision of Tariff (In City-Side Export TSP & Export Demurrage Charges); (ii) Re- Classification of Special Cargo and revision of Tariff (In City Side Export TSP); and Introduction of new service & replication of Airside services to City side Services. DCSC brought out that these services are not mandatory and will be provided on request from the customers. DCSC further submitted that user consultation was initiated by them with the trade bodies like CAAI, DACAI and shipper/consignee etc. for change in the city side tariff.

3.3 DCSC proposes no change in the domestic cargo handling tariff for both city side and airside from previous approved tariff. However, there is a 5% marginal increase in the city side tariff and airside tariff for international cargo.

4.1 The Authority had considered the ATP and issued a Consultation Paper No. 05/2015-16 on 28.08.2015. The last date of receipt of comments was 07.09.2015. In response to the proposal contained in the above Consultation Paper, one comment has been received from Delhi International Airport Ltd. (DIAL).

4.2 DIAL vide their letter no. DIAL/2015-16/Fin.-Acc/7507 dated 09.09.2015 have offered the following comments in response to the above consultation paper:

"..... With reference to above, we support the revised tariff proposal filed by DCSC with respect to Terminal, Storage and Processing charges (TSP), Demurrage and other charges at DCSC Cargo Terminal at IGI Airport, New Delhi...."

4.3 The Statement showing the tariff sub-heads in which the Service Provider has sought an increase in the fifth tariff year i.e year 2015-16 is placed at **Annexure – I**.


5. Upon careful consideration of material available on record, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:

- (i) The Annual Tariff Proposal for remaining period of the fifth tariff year (i.e 2015-16) of the first control period submitted by Delhi Cargo Service Centre India Private Limited (DCSC) for providing Cargo Handling Services at IGI Airport, New Delhi is determined as at **Annexure – II**.
- (ii) DCSC to ensure that there is no double charging in respect of the facilities on airside and city side.



- (iii) DSCS should submit the MYTP and ATP for the 2nd Control Period well in time as per the Guidelines after incorporating the actual financials of 2014-2015.

3 Charges will be on the "gross weight" or the "chargeable weight" of consignment, whichever is higher. Wherever the "gross weight" and (or) volume weight is wrongly indicated on the AWB and is actually found more, charges will be levied on the "actual gross weight" or the "actual volumetric weight" whichever is higher.

4. (*) Special cargo consists of perishable and temperature sensitive products, live animals, hazardous goods, valuables and/or any other such cargo which requires/have special handling/storage instructions.

5. Valuable cargo consists of gold, bullion, currency notes, securities, shares, share coupons, travelor's cheque, diamonds (including diamonds of industrial use), diamond jewellery & watches made of silver, gold, platinum and items valued at USD 1000 per kg & above.

6. For misdeclaration of weight above 2% and upto 5% of declared weight penal charges double the applicable TSP charges will be levied. For variation above 5%, the panel charges will be five times the applicable TSP charges of the differential weight. No penal charges will be there for variation upto and inclusive of 2%. This will not apply to Valuable Cargo.

7. While it is our intention not to allow any other agencies to operate inside the facility, in case for special reason exporters want to engage their own labour, discount of 5% will be granted in TSP charges for offloading the cargo from truck and putting on custom examination area, and on pallets.

8. All invoices will be rounded off to nearest Rs. 5. As per IATA Tact Rule book Clause – 5.7.2, rounding off procedure, when rounding

9. In case of premium service request, such service shall be provided at a premium of 25% over normal handling rates.

10. For special Cargo consisting of perishable & temperature sensitive products the TSP charges for special cargo will only be applicable if temperature control facility is made available other wise general cargo tariff will be applied for such products.



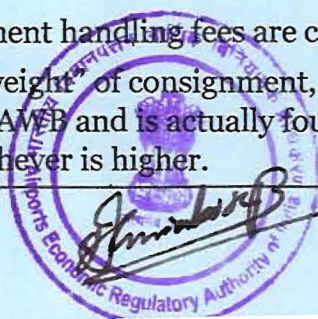

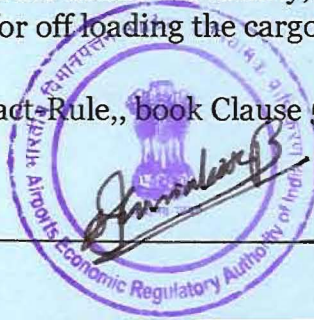
