In the matter of Multi Year Tariff Proposal for the second control period and Annual Tariff Proposal for the 1st tariff year(FY.2016-17) of the second control period submitted by M/s Celebi Delhi Cargo Terminal Management India Pvt. Limited (Celebi) for providing cargo handling services at IGI Airport, New Delhi.

- The Authority vide its Multi-Year Tariff Order (MYTO) Order No. 14/2011-12 dated 07.10.2011, decided to adopt 'Light Touch Approach' for determination of the tariffs for the first control period in respect of Celebi Delhi Cargo Terminal Management India Pvt. Ltd. (Celebi) as the cargo service was assessed as "Material but Competitive". Subsequently, the Authority also determined the annual tariffs for Celebi vide its Order No.11/2012-13 dated 03.08.2012 (for the tariff year 2011-12(T1) and 2012-13(T2)), Order No. 35/2013-14 dated 06.12.2013 (for tariff year 2013-14(T3)), and Order No. 24/2015-16 dated 06.07.2015 (for tariff year2014-15(T4) and 2015-16(T5)). The Authority vide its Order No.50/2015-16 dated 31.03.2016 allowed the AOs/ISPs to continue the levy of tariffs existing as on 31.03.2016 up to 30.09.2016 or till the determination of tariffs for the second control period, whichever is earlier. The Authority vide its Order No. 11/2016-17 dated 29.09.2016 further extended the levy of tariffs as on 31.03.2016 up to 31.03.2017 or till the determination of tariffs for the second control period, whichever is earlier.
- 2.0 M/s Celebi vide letter dated 11.03.2016 submitted their Multi Year Tariff Proposal (MYTP) for the second control period of five years commencing from 01.04.2016 and the Annual Tariff Proposal (ATP) for the first tariff year(FY.2016-17) of the second control period for determination of tariffs for the cargo handling services provided by them at IGI Airport, New Delhi. M/s Celebi proposed an increase of 12% in city side tariffs in their ATP for the first tariff year i.e FY. 2016-17. M/s Celebi also provided the Annual Compliance Statements for the first control period.
- 2.1 In respect of the regulated service(s) provided for cargo facility at the major airports, the Authority considers that materiality of the service is linked to the cargo volume at the major airport. The materiality shall be assessed based on cargo volume in Metric Tonnes (MT) at the major airport as a percentage of cargo volume in MT at all major airports, in

terms of Clause 4.3 of the Guidelines [The Airports Economic Regulatory Authority of India (Terms and Conditions for Determination of Tariff for Services provided for Cargo Facility, Ground Handling and Supply of Fuel to Aircraft) Guidelines, 2011]. The percentage share of cargo volume for IGI Airport (as per the AAI cargo statistics for FY.2014-15) is 27.98% which is greater than 2.5% Materiality Index threshold limit fixed for the subject service. Hence the service is deemed 'material'.

- 2.2 As per the information furnished by Celebi, in Form F1 (b) on the Competition Assessment, following service provider will be rendering similar service at IGI Airport:
- (i) M/s Delhi Cargo Service Centre (DCSC)

The Guidelines provide that where a regulated service is being provided at a major airport by two or more service providers(s), it shall be deemed '**competitive**' at that airport. In the instant case with the total number of players being two, the service is deemed '**material but competitive**'.

- 2.3 As per Clause 3.2 of the Guidelines, based on the assessment of materiality and competition, when such regulated service is deemed 'material but competitive', the Authority shall determine tariff(s) for the service provider(s) based on a 'Light Touch Approach' for the duration of the Control Period. Hence the regulated service being provided by Celebi at IGI Airport, New Delhi is 'material but competitive' and shall come under the 'Light Touch Approach' for tariff determination.
- 2.4 Celebi have furnished the justification for proposed increase in city side tariffs. Further, Celebi has also submitted copies of agreements entered into with agencies/airlines for provision of regulated services at IGI Airport, New Delhi. The Authority also decided to accept the request for confidentiality of documents to the extent requested by Celebi.
- 2.5 As per Clause 11.2 of the Guidelines, the ATP is required to be submitted in the manner and form provided in AI. 8.1 of Appendix I to the guidelines and should be supported by the following documents:
- 2.5.1 Form B -Submission of ATP
- 2.5.2 Form 14(b)-Proposed Tariff Card
- 2.5.3 Details of consultation with stakeholders
- 2.5.4 Evidence of User Agreements clearly indicating the Tariff proposed by the Service Provider.

Celebi has submitted Form B, Form 14(b) and proof of user consultation and copy of some of the user agreements with their Annual Tariff Proposal for the first tariff year i.e FY.2016-17 of the second control period.

- 3.0 The Authority considered the submissions made by Celebi and issued the Consultation Paper No. 02/2016-17 dated 20.12.2016 proposing the following for stakeholder consultation:
 - (i) The service for Cargo handling being provided by Celebi Delhi Cargo Terminal Management India Pvt. Ltd. (Celebi) at IGI Airport, Delhi is "Material but Competitive". Therefore the Authority proposes to adopt 'Light Touch Approach' for determination of tariffs for the 2nd control period w.e.f. 01.04.2016 to 31.03.2021 and accordingly issue the MYTO for the 2nd control period.
 - (ii) The tariff for the first tariff year TI(2016-17) of the 2nd control period for Cargo services rendered by Celebi Delhi Cargo Terminal Management India Pvt. Ltd. (Celebi) at IGI Airport, New Delhi may be approved to be levied from the date of Order as per the tariff card wherein Celebi has proposed an increase of 12% in city side tariffs.

- 3.1 In response to the aforesaid Consultation Paper, comments of the stakeholders are as follows:
- 3.1.1 Shri Ramesh Mamidala, CEO, Celebi made a presentation before the Authority covering the following areas with reference to their MYTP/ATP submissions for the second control period:
 - > Key Investments undertaken by Celebi.
 - > Improvement in operation and services.
 - Investment plans for next control period i.e 2nd CP(FY. 2016-17 to FY. 2020-21).
 - Need and benefits of proposed investments.
 - ➤ Key focus areas in FY. 2016-17.
 - New Products launched/planned.

Shri Mamidala stated that their trade partners appreciated Celebi's investment plans and agreed to the rationale behind the proposed increase of 15% in city side tariffs for the FY.2016-17 sought by Celebi in their Annual Tariff Proposal. Shri Mamidala further stated that the trade partners requested Celebi to review the percentage of proposed increase and consider the best possible increase in line with the interest of both the parties. Shri Mamidala concluded by saying that Celebi on the request of trade community reviewed the tariffs and have proposed an increase of 12% in city side tariffs instead of the earlier proposed increase of 15%.

- 3.1.2 Shri Mukesh Hira, Hony. Joint Secretary, Delhi Customs Clearing Agents Association thanked the Authority for allowing him to express his views on the subject consultation paper. Shri Hira stated that he has to recheck whether the trade community supported the proposed increase of 12% in tariffs. He stated that demonetization of currency had an impact on every business and cargo business is also affected. In the present scenario, the exporters/importers and the CHAs are struggling hard to remain in business. Therefore, Shri Hira suggested that the proposed increase in tariffs by Celebi may be deferred for a reasonable time till the cargo community recovers from the slump in the cargo business.
- 3.1.3 Sh. Ashwani Sharma, Jt. GM (Cargo), AAI stated that he has no comments to offer.
- 3.1.4 Shri Jyoti Kumar Chaudhary, Associate Partner, M/s Hammurabi & Solomon, Advocates & Corporate Law Advisors in their written submission dated 13.01.2017 has raised the following major points of concern.
 - 3.1.4.1 Complete Agreements are not available for scrutiny by stakeholders. Hence, the proposal is vulnerable to challenge on the ground of "reasonableness".
 - 3.1.4.2 The documents furnished for supporting the proposal do not shed enough light as to on what basis the proposed increase in the rate of tariff of 12% has been mooted and how it will help in mitigating the alleged revenue shortfall of Rs. 72.6 crores from the first control period. This apart, the meeting of 07.03.2016 organised by Celebi, in which rate of increase in tariff is claimed to been mooted to 15%, did not appear to have representation of concerned stakeholders. Therefore, the extant proposal warrants proper scrutiny.
 - 3.1.4.3 Instead of static increase in 12% as sought by Celebi, M/s Hammurabi & Solomon have suggested a slab based tariff rate for a given volume of cargo which may balance the interest of service provider as well as user and would play in the interest of "reasonableness". Further, as the materiality index for

Delhi airport being 27.98%, it is unlikely that Service provider would suffer from lower volume of cargo.

4.1 The Authority reviewed the comments of the stakeholders and decided that the increase of 12% in city side tariffs sought by Celebi for the first tariff year FY.2016-17 may be approved as major period of the FY. 2016-17 is already over. However, the Authority will review the audited financial statements of Celebi for the first tariff year before giving any further increase in tariffs.

ORDER

Upon careful consideration of material available on record, as well as submissions made by the stakeholders, the Authority, in exercise of powers conferred by Section 13(1)(a) of the AERA Act, 2008 hereby orders that:

- (i) The services provided by Celebi Delhi Cargo Terminal Management India Pvt. Ltd., the Cargo facility Service provider at IGI Airport, New Delhi are "material but competitive". Hence the Authority will adopt a "light touch approach" for determination of tariff for the 2nd Control Period w.e.f 01.04.2016.
- (ii) The tariffs for the first tariff year (FY. 2016-17) of the second control period for cargo handling services provided by M/s Celebi Delhi Cargo Terminal Management India Private Limited at IGI Airport, New Delhi are determined, as at **Annexure** I and shall be effective from the date of order till 31.03.2017.
- (iii) Tariff determined as above will be maximum and demurrage free period shall be applicable as per Government Orders issued from time to time.
