**In the matter of allowing Concession to RCS Flights under Regional Connectivity Scheme (RCS) – UDAN at Major Airports**

The Central Government vide its letter no. F.No. AV-13011/3/2016-DT dated 21.03.2017 has given direction to AERA under Section 42 of AERA Act for allowing certain concessions on airport charges by airport operators under the Regional Connectivity Scheme (RCS).

The Authority deliberated on the afore-mentioned direction in its 172<sup>nd</sup> Authority Meeting held on 27.03.2017 and decided to implement the directions received from Government.

2. **ORDER:-**

The Authority, in exercise of powers conferred by Section 13(1) of the Airports Economic Regulatory Authority of India Act, 2008, orders that:

- i. Airport operators of major airports (whether under the ownership of the AAI, State Governments, private entities or the Ministry of Defence, Government of India) shall not levy Landing Charges and Parking Charges or any other charge subsuming a charge for such aspects in future on RCS Flights.
- ii. Airfares for all passenger seats on an RCS Flight will not be subject to any levies or charges imposed by the Airport Operator of major airports (whether under the ownership of the AAI, State Governments, private entities or the Ministry of Defence, Government of India) including charges such as PSF, DF and UDF.
