

**AIRPORTS ECONOMIC REGULATORY AUTHORITY OF INDIA****Order No. 12/2017-18****Date of Issue: 29<sup>th</sup> September, 2017**

**In the Matter of Economic Regulation of aeronautical services provided by Airport Operators/Service Providers of Cargo facility, Ground Handling and Supply of Fuel to the Aircraft-Interim Arrangement to continue the levy of existing tariffs till determination of tariffs for the Second Control Period.**

1. This is regarding interim arrangement for levy of tariff for the period beyond 30.09.2017 of the Second Control Period (FY 2016-17 to FY 2020-2021) in respect of the Airport Operators (s) and Independent Service Providers (s) mentioned in the table below:-

The Authority vide its Order No. 50/2015-16 dated 31.03.2016, as an interim arrangement, had extended the continuation of the levy of tariff prevalent on 31.03.2016 for a period of six month w.e.f. 01.04.2016 or till determination of tariff for the second control period, whichever is earlier, in respect of Airport Operator i.e. HIAL, BIAL, CIAL, Airports Authority of India (Major Airports) and Independent Service Providers. The Authority vide its Order No. 05/2016-17 dated 16.05.2016 and Order No. 09/2016-17 dated 23.08.2016 respectively, also allowed M/s Indo Thai and M/s Air India (AIASTSL) to continue to charge the tariffs prevalent on 31.03.2016 for period of six months w.e.f. 01.04.2016 or till determination of tariffs for the 2<sup>nd</sup> control period, whichever is earlier. The Authority vide its Order No. 11/2016-17 dated 29.09.2016 further extended the continuation of levy of tariffs prevalent on 31.03.2016 for a period of six month w.e.f. 1.10.2016 or till determination of tariffs for the second control period, whichever is earlier, in respect of Airport Operators(s) and Independent Service Provider(s). The Authority vide its Order No. 19/2016-17 dated 31.03.2017 further extended the continuation of levy of tariffs prevalent on 31.03.2016 for a period of six month w.e.f. 1.04.2017 or till determination of tariffs for the second control period, whichever is earlier, in respect of Airport Operators(s) and Independent Service Provider(s). The Authority has further decided that the Airport Operators/Independent Service Providers as listed in para-1 (Sl No. 1 to 44) as above may be allowed to continue to levy the tariffs existing as on 31.03.2016, for a period of six months w.e.f. 01.10.2017 or till determination of tariffs for the second control period, whichever is earlier. The Authority has further decided that M/s Indo Thai Airport Management Services Pvt. Ltd (Sl.No. 45 & 46) may be allowed to continue levy of the tariffs existing as on 31.03.2016, for a further period of one month w.e.f. 01.10.2017 or till determination of tariffs for the Second Control period whichever is earlier.

3. The tariffs for the first tariff year (2016-17) of second control period has been determined in respect for the Cargo Operators- M/s Celebi Delhi Cargo Terminal Management India Private Limited (Order No. 16/2016-17 dated 14.02.2017) and M/s Menzies Aviation Bobba (Bangalore) Private Limited (Order No. 18/2016-17 dated 28.03.2017).





4. The Authority is in the process of scrutinizing the MYTP/ATP submissions received from various Airport Operators and Independent Service Providers viz. Cargo Operators, Ground Handling Agencies and Into Plane Service Providers and the determination process is likely to take another 5-6 months. Hence, the Authority decided that the Airport Operators/Independent Service Providers as listed in para-1(Sl. No. 1 to 44) as above may be allowed to continue to levy the tariffs existing as on 31.03.2016, for a period of six months and Sl. No. 45 & 46 for a period of one month w.e.f. 01.10.2017 or till determination of tariffs for the second control period, whichever is earlier.

### **ORDER**

In view of the above, to avoid any regulatory vacuum in respect of the tariffs being levied by the regulated entities, the Authority, in exercise of powers conferred by Section 13 (1) of the Airports Economic Regulatory Authority of India Act 2008, hereby orders that :-

- (i) The Airport Operators/Independent Service Providers as per list (1 to 44) para -1 as above, may be allowed to continue levy of the tariffs existing as on 31.03.2016, for a further period of six months w.e.f. 01.10.2017 or till determination of tariffs for the Second Control period whichever is earlier.
- (ii) The Authority has further decided that M/s Indo Thai Airport Management Services Pvt. Ltd. (Sl No. 45 and 46 of para 1) may be allowed to continue levy of the tariffs existing as on 31.03.2016, for a further period of one month w.e.f. 01.10.2017 or till determination of tariffs for the Second Control period whichever is earlier.
- (iii) The Authority has further, decided that the Independent Service Provider- M/s Celebi Delhi Cargo Terminal Management India Private Limited and M/s Menzies Aviation Bobba (Bangalore) Private Limited may be allowed to continue levy of the tariffs determined by AERA for the first tariff year (FY. 2016-17), for a period of Six months w.e.f. 01.10.2017 or till determination of tariffs for the second tariff year T2 (FY. 2017-18) of the second control period, whichever is earlier.
- (iv) The Authority has issued Tariff Order of Express Industry Counsel of India for providing express cargo service at Mumbai vide order No. 11/2017-18 dated 14.08.2017. However the order has been kept in abeyance till 30.09.2017 and the Authority conducted a stakeholders meeting on 21.09.2017 to elicit the view of stakeholders. The Authority has further decided to keep the order in abeyance for a period of one more month i.e. upto 31.10.2017 or till the Authority takes a final decision in this regard, whichever is earlier.



Hence, the Authority has decided to allow EICI to continue levy of the tariffs existing as on 31.03.2016 for a further period of one month w.e.f. 01.10.2017 or till the Authority decides to implement the tariffs order for the second control period, whichever is earlier.

- (v) The Airport Operator may also ensure compliance of the Order in respect of the Independent Service Providers at the respective major airports.
