

AIRPORTS ECONOMIC REGULATORY AUTHORITY OF INDIA**Order No. 43/2017-18****Date of Issue: 28th March, 2018**

In the matter of Order No. 12/2017-18 dated 29.09.2017 regarding Economic Regulation of aeronautical services provided by Airport Operators/Service Providers of Cargo facility, Ground Handling and Supply of Fuel to the aircraft-interim arrangement to continue the levy of existing tariffs beyond 31.03.2018 for the Second Control Period.

1. This is regarding interim arrangement for levy of tariff for the period beyond 31.03.2018 of the Second Control Period (FY 2016-17 to FY 2020-21) in respect of the Airport Operators (s) and Independent Service Providers (s) mentioned in the table below:-

2. Vide its earlier order No. 12/2017-18 dated 29.09.2017, the Authority had approved the continuation of tariff for the above mentioned parties upto 31.03.2018, except Serial No. 15 to 20. For Serial No. 15, 16, 17, 18, 19 and 20, tariff upto 31.03.2018 was determined vide order nos. 02/2017-18 dated 11.05.2017, 04/2017-18 dated 12.06.2017, 06/2017-18 dated 12.06.2017, 08/2017-18 dated 02.08.2017, 01/2017-18 dated 17.04.2017 and 05/2017-18 dated 12.06.2017, respectively.

3. The Authority is in the process of scrutinizing the MYTP/ATP submissions received from various Airport Operators and Independent Service Providers viz. Cargo Operators, Ground Handling Agencies and Into Plane Service Providers and the determination process is likely to take some time. Hence, the Authority has decided that the Airport Operators/Independent Service Providers as listed in para-1 (Sl. No. 1 to 29) as above may be allowed to continue to levy the tariffs existing as on 31.03.2018, for a period of six months w.e.f. 01.04.2018 or till determination of tariffs for the second control period, whichever is earlier.

ORDER

In view of the above, to avoid any regulatory vacuum in respect of the tariffs being levied by the regulated entities, the Authority, in exercise of powers conferred by Section 13 (1) of the Airports Economic Regulatory Authority of India Act 2008, hereby orders that :-

- (i) The Airport Operators/Independent Service Providers as per list (1 to 29) para -1 as above, may be allowed to continue levy of the tariffs existing as on 31.03.2018, for a further period of six months w.e.f. 01.04.2018 or till determination of tariffs for the Second Control period whichever is earlier.
- (ii) The Airport Operators may also ensure compliance of the Order in respect of the Independent Service Providers at the respective major airports.
