In the matter of tariff(s) for Aeronautical Services in respect of CSI Airport, Mumbai – w.e.f. 01.04.2014.

The Authority had vide Order No. 32/2012-13 dated 15.01.2013, approved the aeronautical tariff(s) for CSI Airport, Mumbai, for the first control period w.e.f. 01.04.2009 to 31.03.2014.

2. The Authority had, vide its letter dated 10.09.2013, informed Mumbai International Airport Ltd. (MIAL) to file their tariff proposal for the second control period starting w.e.f. 01.04.2014.

3. MIAL has, filed its tariff proposal vide letter dated 26.12.2013, for the second control period starting w.e.f. 01.04.2014. The said proposal is under consideration of this Authority.

4. MIAL has further requested that since the determination of tariff for the second control period may take some time, the Authority may allow continuation of existing rates till tariff for second control period is finalised and made effective.

5. The Authority understands that the tariff determination exercise, including the discussion/ deliberations of the Authority on the airport operator's submission; issue of a Consultation Paper containing the proposals of the Operator and the Authority's position; Holding Stakeholder Consultation meeting and considering the stakeholders' responses and issue of final tariff order, may usually take about 4 to 6 months.

6. In view of the above and in order to avoid any regulatory vacuum in respect of the tariffs being levied at CSI Airport, Mumbai the Authority hereby orders that:-

- (i) Aeronautical tariff(s) approved by the Authority vide Order No. 32/2012-13 dated 15.01.2013 shall continue for a further period of two months w.e.f. 01.04.2014, i.e. upto 31.05.2014 or until further orders, whichever is earlier.
- (ii) The revenue so collected by the airport operator (MIAL) during such period shall be adjusted from the Aggregate Revenue Requirement for the second control period starting w.e.f. 01.04.2014.
