In the matter of Annual Tariff Proposal submitted by M/s Cambata Aviation Pvt. Ltd. for third Tariff Year of the first control period for providing Ground Handling Services at Sardar Vallabhhai Patel International Airport, Ahmedabad.

This Authority, vide Direction No. 4/2010-11 dated 10.01.2011, had issued the Guidelines [The Airports Economic Regulatory Authority of India (Terms and Conditions for Determination of Tariff for Services provided for Cargo Facility, Ground Handling and Supply of Fuel to the Aircraft), Guidelines, 2011 prescribing procedures, terms and conditions for determination of tariff for the above mentioned regulated services being provided by Independent Service Provider(s). As per the Guidelines, the service providers are required to submit Multi Year Tariff Proposal (MYTP) for the five-year control period and Annual Tariff Proposal (ATP) for individual tariff years of the Control Period. Accordingly, M/s Cambata Aviation Pvt. Ltd. (Cambata) submitted its MYTP for first control period commencing 01.04.2011 in respect of the tariff for the ground handling services provided at SVP International Airport, Ahmedabad. The Authority had considered the submissions made by Cambata and after due stakeholder consultation, had issued Multi Year Tariff Order (MYTO) No. 32/2011-12 dated 28.11.2011 wherein it was decided to adopt "light touch approach" for determination of tariff for the first control period. Subsequently, the tariff for the first (FY 2011-12) and second (FY 2012-13) tariff years of the first control period were determined vide Order No. 43/2012-13 dated 15.02.2013.

2. Thereafter, Cambata, vide its letter dated 29th March, 2013, submitted its ATP for the third tariff year. The Authority considered the submissions made by Cambata and issued Consultation Paper No. 15/2013-14 on 09.07.2013 for stakeholders consultation. No comments were received in response to the said consultation paper.

ORDER

- 3. Upon careful consideration of material available on record, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airport Economic Regulatory Authority of India Act, 2008, hereby orders that:
 - (i) The maximum tariffs, for the third tariff year w.e.f 01.04.2013 to 31.03.2014 of the First Control Period, for ground handling services
