In the matter of Annual Tariff Proposal submitted by Bhadra International India Ltd. for Third Tariff Year (2013-14) of the first control period for providing Ground Handling Services at Netaji Subhash Chandra Bose International Airport, Kolkata.

The Authority had, in its Order No. 30/2011-12 dated 30.11.2011 ordered that it shall adopt a "light touch approach" for the Ground Handling Services provided by Bhadra International India Ltd (Bhadra) at Netaji Subhash Chandra Bose International Airport (NSCBIA), Kolkata and pursuant to stakeholder consultations determined tariffs for the first year of the first Control Period w.e.f. 01.04.2011. Subsequently, the Authority determined the tariffs for second tariff year of the current control period vide Order No. 27/2012-13 dated 22.11.2012.

2. Bhadra, vide its letter No. Nil dated 19.02.2013 requested the Authority "to kindly consider and approve the same rate as proposed by Bhadra for the first tariff year of the first control period for the 3rd tariff year also in respect of all the four airports namely Chennai, Kolkata, Trivandrum and Calicut Airport" for the ground handling services provided at these airports.

3. The Authority considered this submission made by Bhadra and issued Consultation Paper No. 1/2013-14 on 01.04.2013.

4. No comments were received from the stakeholders in response to the proposal contained in the Consultation Paper No.01/2013-14 dated 01.04.2013.

ORDER

5. Upon careful consideration of material available on record, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that:

(i) The Tariffs for the third tariff year (2013-14) of the First Control period for Ground Handling Services provided by M/s Bhadra International India Ltd. at

Netaji Subhash Chandra Bose International Airport, Kolkata is determined as at **Annexure-I.**

- (ii) These Tariffs will be the maximum rates effective from 01.04.2013.
- (iii) The instant determination permits M/s Bhadra International India Ltd. to only charge/levy certain tariffs for ground handling services provided by it at Netaji Subhash Chandra Bose International Airport, Kolkata and does not confer any rights/claims whatsoever on M/s Bhadra International India Ltd for appointment as service provider for providing any service at NSCBIA, Kolkata. Further, for this purpose, this order will not affect the rights of any party in this matter.
