In the matter of Annual Tariff Proposal for Third Tariff year submitted by Kerala State Industrial Enterprises Limited in respect of Cargo Services being provided at Thiruvananthapuram International Airport, Thiruvananthapuram

The Authority had considered the Multi Year Tariff Proposal (MYTP) for 1st Control period (i.e. 2011-12 to 2015-16) submitted by Kerala State Industrial Enterprises Limited (KSIEL) for the Cargo Services being provided at Thiruvananthapuram International Airport, Thiruvananthapuram and issued Order No.04/2011-12 dated 27.07.2011 ordering to adopt a light touch approach for determination of tariffs. Thereafter the Authority had issued Orders No. 37/2011-12 dated 14.03.2012 and 13/2012-13 dated 06.08.2012, determining the tariffs for the first tariff year (2011-12) and second tariff year (2012-13) of the current control period under light touch approach, respectively.

2. Thereafter, KSIEL vide letter no. ACC/60(1) dated 31.12.2012 submitted the Annual Tariff proposal (ATP) for the Third Tariff year. KSIEL has in the ATP submitted that they have not entered into any written agreement with the users and also clarified that the tariff proposal is on non-discriminating basis with reference to conditions of tariff and there are no discounts other than volume based tariffs.

3. The ATP submitted by KSIEL, was put up for stakeholder consultation vide Consultation Paper No. 42/2012-13 on 07.03.2013 with 14 days response time. The last date of receipt of comments was 21.03.2013. In response thereof no comments have been received from the stakeholders, except letter dated 18.03.2013 from KSIEL, requesting Authority to expedite the orders in the matter, so as to implement the tariff revision w.e.f. 01.04.2013.

ORDER:

4. Upon careful consideration of material available on record, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airport Economic Regulatory Authority of India Act, 2008, hereby orders that:



- (i) The tariff for third tariff year (w.e.f. 01.04.2013 to 31.03.2014) for Cargo Services provided by M/s Kerala State Industrial Enterprises Limited at Thiruvananthapuram International Airport, Thiruvananthapuram is determined, as at **Annexure- I**.
- (ii) These tariffs will be the maximum and demurrage free period will be as per Govt. of India instructions issued from time to time.
