In the matter of Economic Regulation of aeronautical services provided by independent Service Providers of Cargo Facility, Ground Handling and Supply of Fuel to the Aircraft – Interim arrangement to continue the levy of existing tariff beyond 31.03.2019 for the second control Period (01.04.2016 to 31.03.2021)

This is regarding interim arrangement of levy of existing tariff beyond 31.03.2019 for the Second Control Period (01.04.2016 to 31.03.2021) in respect of the independent Service Providers as per the table below:

2. M/s IOSL & M/s BSSPL had earlier intimated that their respective Concession Agreements with the Airport Operator BIAL, for their ITP Operations at Bangalore Airport, were valid up to 23.05.2019. Accordingly, the Authority, determined the tariff(s) in respect of these firms up to 23.05.2019 vide its Order No. 23/2018-19 dated 05.10.2018 and Order No. 24/2018-19 dated 10.10.2018, respectively. It has now been intimated that, the Airport Operator BIAL, has awarded new contracts to M/s IOSL & M/s BSSPL w.e.f. 24.05.2019 for a period of 10 (ten) years, and, fresh Concession Agreements have been executed in this regard. Both these ISPs have submitted their MYTP/ATPs recently which are under process and will take some time for determination of tariff.

3. AAICLAS vide the letter dated 13.05.2019 has informed that the Contract of M/s GSEC Ltd for cargo handling service at Ahmedabad Airport was valid up to



31.05.2019. AAICLAS has further informed that they have extended the Contract for another 4 (four) months i.e. up to 30.09.2019, and, have also initiated tender action for appointment of a new agency.

4. M/s GMR Hyderabad Air Cargo And Logistics Private Limited has informed that the name of the earlier operator i.e. M/s Hyderabad Menzies Air Cargo Pvt. Ltd. has been changed to GMR Hyderabad Air Cargo And Logistics Private Limited due to change in the shareholding of the company and they have submitted their proposal which is under process and will take some time for determination of tariff.

ORDER

In view of the above, to avoid any regulatory vacuum in respect of the tariff(s) being levied by the regulated entities, the Authority, in exercise of powers conferred by Section 13(1) of the Airport Economic Regulatory Authority of India Act, 2008 hereby orders that:-

- (i) M/s IOSL and M/s BSSPL, ITP Operators at Bangalore Airport (Sl. No.1 & 2 above), are allowed to continue levy of existing tariff(s) as on 23.05.2019 up to 30.09.2019 or till determination of tariff(s) for the remaining period of Second Control Period (01.04.2016 to 31.03.2021) whichever is earlier.
- (ii) M/s GSEC, Cargo handling service provider at Ahmedabad Airport is allowed to continue levy of existing tariff as on 31.05.2019 up to 30.09.2019. Further, AAI/AAICLAS may intimate the outcome of the tender action and also ensure the timely submission of proposal by the newly appointed Agency to the Authority.
- (iii) M/s GMR Hyderabad Air Cargo And Logistics Private Limited is allowed to continue levy of existing tariff as on 31.03.2019 (which were approved in respect of M/s Hyderabad Menzies Air Cargo Pvt. Ltd.), up to 30.09.2019 or till determination of tariff(s) for the remaining period of Second Control Period (01.04.2016 to 31.03.2021) whichever is earlier.
- (iv) The Airport Operators may ensure compliance of the Order.
