Date of Issue 13.05.2020

In the matter of Order No. 33/2019-20 dated 24.03.2020 regarding Economic Regulation of Aeronautical Services provided by the Independent Service providers of Cargo facility, Ground Handling and Supply of Fuel to the aircraft – Interim arrangement to continue the levy of existing tariffs for the First Control Period.

This is regarding interim arrangement of levy of tariff for the period mentioned below for the First Control Period in respect of Independent Service Provider(s) mentioned in the table below:

- 2. The Authority noted that the Airport Operator viz. Airports Authority of India (AAI) has issued notice of termination of the license for ground handling services to M/s Bhadra International (I) Private Limited for Mangalore and Trichy Airports and to M/s Indo Thai Airport Management Services Private Limited for Amritsar and Varanasi Airports and AAI has also initiated tender action to appoint new ground handling agencies in terms of new Ground Handling Regulations. The Authority also noted that AAI has granted extension of notice period to M/s Bhadra up to 25.10.2020 for Mangalore and Trichy airports and to M/s Indo Thai up to 31.12.2020 as their tender action is under process and new agencies will be appointed after finalization of the tender action.
- 3. The Authority further noted that the AAI has given extension of time as a temporary arrangement till new agencies are appointed as per new Ground Handling Regulations. Hence the Authority is of the view that the existing tariff(s) as proposed by M/s Bhadra and M/s Indo Thai for providing ground handling services at above airports, may be allowed to continue till the date of extension as given by AAI as an interim arrangement to avoid any regulatory vacuum or till determination of tariffs by the Authority whichever is earlier. The order will be effective from the date of issue of order and the prior period will stand regularized.

### ORDER

In view of the above, to avoid any regulatory vacuum in respect of the tariffs being levied by the regulated entities, the Authority, in exercise of powers conferred by Section 13(1) of the Airport Economic Regulatory Authority of India Act, 2008 hereby orders that:-

- (i) M/s Bhadra International (I) Private Limited is allowed to continue the levy of the existing tariffs up to 25.10.2020 or till determination of tariffs by the Authority whichever is earlier for providing ground handling services at Mangalore and Trichy Airports as per **Annexure A**.
- (ii) M/s Indo Thai Airport Management Services Private Limited is allowed to continue the levy of the existing tariffs up to 31.12.2020 or till determination of tariffs by the Authority whichever is earlier for providing ground handling services at Amritsar and Varanasi Airports as per Annexure B.
- (iii) The tariff as mentioned above will be maximum tariff to be charged.
- (iv) M/s Bhadra International (I) Private Limited and M/s Indo Thai Airport Management Services Private Limited should not exceed the tariffs for its Non-Scheduled Operations as approved by AERA for its Scheduled Operations for similar category of aircrafts.

- (v) The order will be effective from the date of issue of this order and the existing tariff with effect from these airports become Major Airport will also stand regularized.
- (vi) The Airport Operators may ensure compliance of the Order.
