The Authority had issued a Multi-Year Tariff Order (MYTO) No. 09/2011-12 dated 14.09.2011 in respect of Gujarat State Export Corporation Limited (GSEC), Air Cargo Service Provider at SVPI Airport, Ahmedabad wherein the Authority had decided to adopt 'light touch approach' for determination of the tariff for the first Control Period and ordered GSEC for submission of the Annual Tariff Proposal for the consideration of the Authority in accordance with the Guidelines.

2. GSEC submitted the Annual tariff proposal (ATP) for the first tariff year ie. 2011-12 in December 2011 with a proposed increase of 10% in the existing tariff in some items stating that the existing tariff was made effective from 15.01.2008 and since then there was no revision. However, the ATP was not supported by documentary evidence of stakeholder consultation and/or user agreements as provided in the Guidelines of the Authority. GSEC, vide their letter dated 01.02.2012 informed that formal meeting pertaining to tariff revision was not held.

3. Further, considering that the ATP for the second tariff year (2012-13) was also due in January 2012, GSEC was advised to submit ATP for the second year also along with documentary evidence of stakeholder consultation and copies of valid user agreements indicating the proposed tariff for consideration of the Authority.

4. In response, GSEC have proposed to continue with the existing tariff for the entire duration of the first control period and vide their submissions dated 15.09.2012, stated as under;

"We regret the delay in responding to these communications. We have been holding consultations with end users on the proposed revised tariff.

We are unable to reach an agreement and have, therefore, decided to withdraw the proposed tariff for 1st control period.

We are enclosing a copy of request letter received from Ahmedabad Custom House Agents Association requesting holding the current tariff levels.

We shall continue with our consultations and in the meantime, will continue with old tariff."

5. GSEC has also attached the letter of the President, Ahmedabad Custom House Agents' Association addressed to GSEC Limited wherein it is mentioned that,

".....In view of stagnating volumes from Ahmedabad, our members feel that tariff increase would be difficult to be passed on to exporters and importers.

We would like to request you to hold the current tariff levels for this financial year...."

6. The proposal has been considered by the Authority, and the Authority has tentatively decided to make the following proposal for stake holder consultation:-

- (i) With effect from 01.04.2011, the tariffs for cargo services provided by Gujarat State Export Corporation Limited (GSEC), Air Cargo Service Provider at SVP International airport, Ahmedabad are tentatively decided to be determined for the first control period (i.e.01.04.2011 to 31.03.2016) at the same rates as were prevailing on 31.3.2011.**(Annexure-I)**

7. In accordance with the provisions of Section 13(4) of the AERA Act, the proposal contained in para 6 above is hereby put forth for stakeholder consultation. To assist the stakeholders in making their submissions in a meaningful and constructive manner, necessary documents are enclosed **(Annexure-II collectively)**. For removal of doubts, it is clarified that the contents of this Consultation Paper may not be construed as any Order or Direction of this Authority. The Authority shall pass an Order, in the matter, only after considering the submissions of the stakeholders in response hereto and by making such decision fully documented and explained in terms of the provisions of the Act.

8. The Authority welcomes written evidence-based feedback, comments and suggestions from stakeholders on the proposal made in para 6 above, latest by **06.12.2012** at the following address:


