IN THE MATTER OF DETERMINATION OF INTO PLANE SERVICE CHARGES FOR BHARAT STARS SERVICES PRIVATE LIMITED (BSSPL) PROVIDING INTO PLANE SERVICES (ITP) AT KEMPEGOWDA INTERNATIONAL AIRPORT (KIA), BANGALORE FOR THE 3RD CONTROL PERIOD (FY 2021-22 TO FY 2025-26).

- The Authority vide Order no. 15/2021-22 dated 10th September, 2021 determined the Into Plane Service charges in respect of M/s Bharat Stars Services Private Limited (BSSPL) providing ITP services at Kempegowda International Airport (KIA), Bangalore for the Third Control Period (FY 2021-22 to FY 2025-26).
- 2. Subsequent to the issue of Order, M/s BSSPL vide letter dated 22.10.2021 has submitted that due to a clerical error, the period for defueling and refueling was inadvertently mentioned as "Within 48 Hrs" and "Beyond 48 Hrs" instead of "Within 6 Hrs" and "Beyond 6 Hrs" in their proposed tariff card enclosed with MYTP/ATP. The same error appears in the Tariff Rate Card forming part of the aforesaid Tariff Order No. 15. Accordingly, the Authority has decided to amend the tariff rate card.
