1. BACKGROUND

Delhi Cargo Service Center Private Limited, a company registered under the Companies Act, 1956 at Delhi and having its Registered Office at Cargo Terminal 2, Gate No. 5, Air Cargo Complex, Indira Gandhi International Airport, New Delhi – 100 037 (herein termed as "DCSC") was awarded a 25 years concession Delhi International Airport Limited (herein termed as "DIAL") to design, build, develop, finance, operate and manage an Integrated Air Cargo Terminal (herein termed as "CT") IGI Airport, New Delhi. Before the construction of the New Cargo Terminal could be undertaken, a terminal for handling of Domestic Cargo was also developed and become operational at Delhi Airport from May, 2010. New Cargo Terminal building was made operational for handling of International Cargo from March, 2012. Domestic Cargo Handling operations continues from the existing facility- the Domestic Cargo Terminal.

In terms of Sec. 15 of AERA Act, the services being provided by DCSC has been determined to be Regulated Service. As such DCSC had filed its Multi Year Tariff Proposals ("MYTP") as well as Annual Tariff Proposal ("ATP") for cargo handling services for approval of the authority. Multi Year Tariff Proposal for the First Control Period (FY.2011-12 to FY.2015-16) & Second Control (FY.2016-17 to FY.2020-21) was approved by AERA vide its Order No. 13/2011-12 dated 29th Sep, 2011 & Order No. 2/2017-18 dated 11th May, 2017 respectively.

It was determined in terms of the proposal that the services being provided by DCSC was both Material and Competitive. The Authority vide its Multi-Year Tariff Order (MYTO) Order No. 13/2011-12 dated 07.10.2011, decided to adopt 'Light Touch Approach' for determination of the tariffs for the first control period. Subsequently, the Authority also determined the annual tariffs for cargo handling services, as provided by DCSC for first tariff year (FY. 2011-12) & second tariff year (FY. 2012-13) vide its Order No. 05/2012-13 dated 21.05.2012, third tariff year (F.Y. 2013-14) vide its Order No. 30/2013-14 dated 31.07.2013, forth tariff year (F.Y. 2014-15) vide its Order No. 18/2014-15 dated 06.02.2015 and fifth tariff year (F.Y. 2015-16) Order No. 39/2015-16 dated 04.11.2015, of the First Control Period (FY.2011-12 to FY.2015-16) respectively.

The Authority vide its Order No. 11/2016-17 dated 29.09.2016 extended the levy of tariffs as on 31.03.2016 up to 31.03.2017. The Authority vide its Order No. 19/2016-17 dated 31.03.2017 further extended the levy of tariffs as on 31.03.2016 up to 30.09.2017. But Authority vide Order No. 02/2017-18 dated 11.05.2017, decided to adopt same 'Light Touch Approach' for determination of the tariffs for the second control period(FY.2016-17 to FY.2020-21). In this order authority also determined the annual tariffs for cargo handling services, as provided by DCSC for the first tariff year (FY. 2016-17) & extended the same tariffs rates for the second tariff year (FY. 2017-18), of the Second Control Period respectively.

Vide Clause 10.8 of the said guideline for Tariff Determination it is required to file Annual Tariff Proposal prior to the start of each Tariff Year commencing 1st April, 2018.

2. REGULATORY APPROCAH TO TARIFF DETERMINATION

As per the AERA [Airports Economic Regulatory Authority of India (Terms and Conditions for Determination for services for Cargo Facility, Ground Handling and Supply Fuel to the Aircraft) Guidelines, 2011], the Authority shall follow a three-stage process for determining its approach to the regulation of a regulated service.

a. Materiality Assessment

Materiality of the service is linked to cargo volume at the major airport. It has already been established that in case of Delhi Airport Cargo, the volume of cargo justified regulatory oversight. This condition has not been changed. Hence, the service is deemed 'material'.

b. Competition Assessment

In our MYTP it has been stated that we faced competition from Celebi Delhi Cargo Terminal Management India Pvt. Ltd who is the second concessionaire for providing cargo handling services at Delhi Airport. This condition has also not been changed at time of this filing. Hence, the cargo services at IGI Airport, Delhi are 'Competitive'.

c. Assessment of reasonableness of the user agreements between the service providers and the regulated services: -

As already submitted, services are provided to two broad categories of users:- Shippers and Consignees represented by their agents on city side to whom Terminal, Storage and Processing Charges are levied besides demurrage in case the shipment is cleared beyond the free period. Additionally, document handling fees are also levied for issuance of delivery order in case such work is outsourced to us by the airlines.

The city side tariff which are commonly applied to all users, are determined using consultative approach with Users of the facility namely the forwarders and the shippers. Trade bodies like FIEO, CII, FICCI, ASSOCHAM, ACAAI, DCAAI and DCCAA are also involved in such discussion and negotiation as appropriate.

On the other hand, the airside charges are airline specific and fixed after detailed negotiation with specific airlines based on the volume of cargo to be handled, service level agreement, specific handling requirements and such other factors. Agreements with Airlines are signed based on the Standard Ground Handling Agreements (herein referred to as "SGHA") as per IATA Guidelines. Such negotiations are on-going and are entered into from one-year upto five years.

Given the above factors, it is contended that the cargo handling services being provided by DCSC at Delhi Airport is material but competitive and therefore the tariff should be regulated by the Authority under Light Touch Approach as per Chapter V of your guidelines.

3. IMPLEMENTATION OF THE APPROVED TARIFF

The Annual Tariff Plan for domestic and international cargo for the F.Y.2016-17 was filed with Authorities in 11th March ,2016 .While the company expected to receive the approval of this at the beginning of F.Y. 2016-17 but the order from the authority approving the tariff for the same was received only on the 11th May, 2017 vide order no. 02/2017-18 that was after delay of 14 months approximately thereby causing a deficit of approximately Rs.10 Crores in the said period. The late approval of the order resulted in the company charging the old tariff during the period of delay.

4. TARIFF PROPOSAL AND JUSTIFICATION FOR INCREASE:-

For the Tariff Year 2018-19, DCSC is proposing an increase in the all the tariff rates for International and Domestic Cargo which is currently handled at the Cargo Terminal-2, w.e.f. 1st April, 2018. The increase in the tariff for majority of tariff items is around 34%. Some minor tariff items have been revised by more than 34% in order to adjust them to their respective cost.

4 (a) DEVELOPMENTS AND FURTHER FACILITIES:-

DCSC is committed to provide world class facilities to its users. In regard DCSC has carried our following major developments & to strengthen its commitment.

- ➤ DCSC invested approximately Rs.32 crores to construct a new express Cargo Terminal (Project T2) at Delhi Airport having area & capacity of approximately 23,000 sq.mtrs & 2.25 lacs MT per annum respectively.
- ➤ Development of cargo handling infrastructure (Installation of two 5 Ton hoists construction of fully equipped office space of 6000 sq.fts at area 1B,dedicated warehouse space) specially for Air India airline ,costing the company around Rs.7 cores.
- > Invested approximately Rs.3 crores to revamp its IT infrastructure.
- DCSC has extended the area of its Domestic terminal by 872 sq.mtrs and constructed a mezzanine floor & dedicated fully equipped office space for its existing customers .DCSC invested approximately 3 crores in this.
- ➢ Development of mobile application by the name of "TURANT-CSC" TURANT CSC has been developed keeping in view to provide better, fast and real time information to its customers as It provides the complete tracking of shipments in both export and imports in real time.
- > An area of approximately 1000 sq.mtrs has been developed to cater the storage of Vulnerable Cargo.
- Construction of trade facilitation center specially for agents.
- > DCSC has installed a single point window system for faster processing of special cargo.

> DCSC has developed a separate lane for handling express delivery.

4 (b) USER CONSULTATION MEETING CONDUCTED TO PRESENT AND DISCUSS TARIFF PROPOSAL FOR THE FY 2018-19

DCSC conducted USER Consultation Meeting with their stake holders & trade members to present Tariff proposal for the FY 2018-19, on 7th Nov'17 at DCSC Cargo Terminal.

In the above said User-meeting, Mr. Venugopal Bangera, CEO DCSC, explained to the trade, various initiatives/developments and key Investments undertaken by DCSC to improve the Operation and Services during the period:

> Investment / Operational Developments

- Additional 10 Ton ULD & two 5 Ton Loose Cargo Hoist installed for faster intake and delivery of Import Cargo.
- Dedicated area for storage of Vulnerable Cargo.
- Implementation of HHT (hand held terminal) as part of automations.
- Extension of Import Warehouse Area to reduce the congestion and faster processing of cargo
- Dedicated window for assisting Special cargo handling.

Additional Infrastructure:

- Construction of another new Greenfield Cargo Terminal by DCSC (DCSC Cargo terminal-2), having plot area of approx. 23,000 sq.mtrs, for catering to Express and other General Cargo, adding additional capacity of 225,000 MT per annum at Delhi Airport. The said upcoming facility will be ready by Feb'18 for Operational purpose.
- Airside temperature Cool Dolly for transportation of cargo to Aircraft
- Express Services A separate lane dedicated to express handling of shipment as per customer's demand.
- Upcoming Animal Quarantine Facility.

> IT Developments

- Launch of E-Freight.
- Trade Facilitation Center at Customer Care for agency to track and trace.
- Launch of E-Delivery order.
- IT interface in the Cargo Acceptance & Delivery Procedure
- Launch of Dash Boards Live displays.
- IT Visibility Visibility to Customer Track & Trace DCSC Portal. Launch of Mobile App - TURANT - CSC.

Further to this, Mr. Vipin Jain, COO DCSC, presented various issues in the meeting which the trade had raised/flagged in the previous meetings and the actions taken by DCSC on issues accordingly. He also presented some of the Excellence Projects that the company has undertaken to improve processes and the service standards of DCSC. He explained to the trade various initiatives taken by DCSC w.r.t. Facilitation Center for the trade in the 2nd floor,

inside the Terminal, 24 X 7 Cargo acceptance and clearance in the Terminal etc., to smoothen the clearances of trade. He also stated that the company is committed towards delivering high standards of services to its customers and appreciated the support the company has received from the trade members.

4 (c) JUSTIFICATION FOR INCREASE

Mr. Venugopal Bangera, CEO DCSC, explained to Trade partners, DCSC's investment plans & detailed justification behind the proposed increase in the tariff for majority of tariff items by 34%for International and Domestic Cargo Handling Services for the Financial Year 2018-19 sought by DCSC in the Annual Tariff proposal.

i) Delay in approval for previous Tariff Order (FY 2016-17):DCSC applied for tariff increase of 7% for the first tariff period (FY2016-17) in January 2016 and Authority (AERA) approved the same only in May 2017 hence implementation of revised tariff rates was delayed by nearly 14 months. This contributes to the incremental revenue loss to the tune of Rs.10 Crores .Since the Tariff Order for the period (FY2016-17) was approved only in May'17, the late approval of the said order caused the company to continue to charge the old tariff for the period FY 2017-18, affecting its financial position.

ii) Increase in Operating Cost:-

- (a) Increase in Statutory Payment (Salary Cost): The Office of the Chief Labour Commissioner, Ministry of Labour & Employment, Government of India vide its Order No. 1/13(1)/2017-LS-II dated 19.01.2017 increased the minimum rate of wages for various categories of people with effect from Jan'17. Again, in the month of April, vide its Order No. 1/13(7)/2017-LS-II dated 01.04.2017 the Office revised the minimum wages. Both the revisions in the minimum wages rates were in tune to almost by 43% in the period from Jan 2017 to May 2017. Apart from impact of minimum wages, salary of employees has been increased by approximately 12 %.
- **(b)** Land License fees: Automatic increase in land license fees by 7.5 % every year payable to Airport Operator.
- (c) Electricity & Other Administrative Overheads: Other operating expenses i.e electricity & Other Administrative Overheads have also gone up.

The general expenses (i.e Hire equipment lease charges, Legal Expenses, Packing Material Expenses) increased in other operating costs is caused due to inflation (7 % increase as indicated by CPI Index).

iii) Significant capital expenditure being incurred to facilitate faster clearing and the work being carried out to improve operational efficiency.

While it is our intention not to allow any other agencies to operate inside the facility, in case for special reason exporters want to engage their own labour, discount of 5% will be granted in TSP charges for offloading the cargo from truck and putting on custom examination area, and on pallets.

In case of premium service request, such service shall be provided at a premium of 25% over normal handling rates.

For special Cargo consisting of perishable & temperature sensitive products the TSP charges for special cargo will only be applicable if temperature control facility is made available other wise general cargo tariff will be applied for such products.


