Enclosed please find herewith the Annual Tariff Proposal for the financial year 2019-20 and 2020-21, being the fourth and fifth tariff year of the second control period.

We would like to bring to your kind notice that prices for Ground handling & Corporate Aviation are remain unchanged since 1<sup>st</sup> April 2015 and for Bridge Mounted Equipment (BME) services it is remained unchanged since 1<sup>st</sup> April 2016. However, during these four years period the cost of operations has increased substantially particularly the following;

- Staff cost, due to increase in minimum wages by 60.3% (₹ 9,500 in Apr-15 to ₹ 15,233 in Jan'19).
- Fuel cost increased by 23.4% from ₹ 55.69 to ₹ 68.76 per litre.
- Wholesale Price Index (WPI) by 8.9% from Apr-15 110.2 to Dec-18 120.0.

Considering the above fact, we are proposing the increase in prices for Ground Handling @ 10% and Corporate Aviation & BME services @ 6% effective from 1<sup>st</sup> April 2019.

We would also like to inform you that we have conducted the stakeholders' consultation for our services at CSMI Airport on 10<sup>th</sup> & 11<sup>th</sup> Dec 2018 wherein the stakeholders were briefed on Company's operations and future initiatives. All the concerns of stakeholders were addressed to the concerns of the co

COO, shared brief milestones CELEBI achieved in India:

- The contract award was announced by the airport's operator, Mumbai International Airport Private Ltd (MIAL), on 1<sup>st</sup> November 2008 and now the existing ground handling concession has been further extended for the period of Ten years w.e.f. 1<sup>st</sup> January, 2020.
- The first ground handling service provided by Çelebi NAS Airport Services India Pvt. Ltd. at Chhatrapati Shivaji Maharaj International Airport was to British Airways in June 2009.
- Presence since 2009
- Employee strength of more than 2500 personnel at CSMIA Mumbai, all in our payroll
- Modern equipment in line with best Industry Standards
- Permanent Security Clearance and ISAGO certification

Mr. Cem Sensoz apprised attendees that Celebi is currently available at six stations in different States across India. And CELEBI is confident to further expand its foot prints in other part of India. He shared that CELEBI is one of the bidder for Hyderabad & AAI Tenders and looking forward positively for its growth in Indian Aviation Sector. Also to inform that as on the date of finalisation of this minutes CELEBI has been awarded to provide Ground Handling Services at Hyderabad for a period of 10 years.

COO shared CELEBI's service portfolio globally as well as in India detailed as below:

- Supervision and Administration
- Passenger Services
- Ramp Services
- Baggage Handling
- Exterior and Interior Aircraft Cleaning
- Water and Toilet Services
- ULD management, Control
- Load Control and Flight Operation Services

Mr. Saurabh Dalvi, apprised stakeholders that CELEBI is currently having following certifications for its services:

- ISO 9001:2015 Certification done in June 2017 valid till June 2020
- ISO 14001:2004 Certification renewed in May 2018 valid till May 2021.
- BS OHSAS 18001:2007 Certification renewed in May 2018 valid till March 2021
- ISAGO Certification valid till May 2019.
- RA3 certification done in May 2014 be valid till May 2019.

Further, on the equipment side he mentioned that CELEBI keeps on studying how can they can modify the equipment to make them environment friendly. He informed that all equipment are conventional aviation purposed equipment. CELEBI's GSE manufacturers include Schopf, Mulag, and Charlatte etc. He updated the GSE management process in CELEBI and implementation of SAP system in order to control, follow, plan, perform and organize GSE's needs and maintenance & repair activities. And CELEBI has constant focus on improving the state of the art technology vision in order to meet the needs of customer efficiently. CELEBI is evaluating inducted electrical equipment to make Airport more environment friendly. Mr. Tauseef Khan & Mr. Adil Bhat also presented information on the IT systems and technology being used by CELEBI for increasing the productivity and maximum utilisation of equipment's. And how with introduction of various new tools, the overtime is being managed & reduced. They shared the details of new software which has been implemented at Mumbai for resource planning at Mumbai and how well it is working. They also informed that similar project is in process of being initiated shortly at Delhi Station. Further, Mr. Adil Bhat briefed about GSE construction facility being carried out by CELEBI & MIAL at the Mumbai Airport which is expected to be ready to use from June 2019.

Thereafter, CEO highlighted the features of new planning software which is used from the control rooms by CELEBI and this is most expensive system CELEBI has invested upon and further he recommended the stakeholders to give visit to the control rooms.

In the last Mr. Laxman Prasad, CFO proposed Annual Tariff Plan Proposal and it was mentioned that current AERA approved prices is remain unchanged from 1<sup>st</sup> April 2015, however during this period cost of operation has increased beyond inflation due to significant increase in minimum wage in the year 2017. Considering the above facts we will propose to AERA for increase of price @ 10% for FY1920 & FY2021 after a gap of four years.

After the detailed presentation, stakeholders were invited for their queries and question and answer session began:-

- CFO explained that as of now it is for FY 1920 & FY2021 and will be decided afterwards for the further years, this reply was w.r.t. the query raised by Mr. Sameer Saxena station manager, Etihad in respect to the tariff hike will be applicable for how many years?
- another query raised by Mr. Viraf Mistry Station Manager, British Airways regarding provision for ULD storage, stacking of ULD in the GSE Facility and to this Mr. Adil Bhat replied that currently we are equipped with the enough space at Sierra bay for storage of the same.
- Mr. Abdul Rahman Aljuroori Station Manager, Iraqi Airways enquired that any technical assistance from CELEBI is required to be incorporated in Agreements (SLA) and to this Mr. Tansu replied that these commercials to be discussed and agreed between the Parties separately.

Meeting was originally scheduled to be commenced at 11.00 a.m. however looking at the unavailability of major stakeholders; the meeting was adjourned for another 30 minutes.

Considering the availability of the Stakeholders, the meeting commenced at 11.30 a.m.

Mr. Saurabh Dalvi, Station Manager of Celebi NAS Airport Services India Private Limited ("CELEBI") welcomed all the stakeholders, present in the meeting and thanked them for joining the event. He made keynote address & thanked all the stakeholder of the CELEBI for their excellent support and co-operation extended by them.

Mr. Laxman Prasad, Chief Financial Officer of CELEBI welcomed all Stakeholders for marking their presence in the meeting. He apprised the attendees about the scope & objective of the Stakeholders Meeting. He also gave detailed

Mr. Saurabh Dalvi, apprised stakeholders that CELEBI is currently having following certifications for its services:

- BS OHSAS 18001:2007 Certification renewed in May 2018 valid till March 2021

COO highlighted that CELEBI hires all its manpower on its own payroll for providing ground handling services in India. CELEBI has not deployed any subcontractor or contractual manpower to provide its services. He mentioned CELEBI strongly believes that one of the formulas for success is competent & satisfied employees. He shared some practices followed in CELEBI for effective employee engagement. CELEBI has well structured operational training system (AVSEC/classroom trainings). He shared that in CELEBI to keep the motivation levels high we regularly conduct social gatherings, meetings with the Senior Management to engage with employees. How in CELEBI award & reward process is being followed for recognition of talent and how the talent is being recognised by awarding bonus at events like Kudos, Fun at Work etc. He informed that in CELEBI, we conduct Annual Employee Satisfaction Surveys to analyse employee satisfaction and to take necessary actions as per employees' needs. He further stated that taking into consideration the well-time salary payment and good amount of bonus declared this year, the employee attrition rate at CELEBI is reduced by 40%. Mr. Cem Sensoz also shared details of CELEBI Quality Management System which is maintained through regular internal audits as per defined frequency based on ISAGO, ISO 9001, ISO 14001, BS OHSAS 18001 standards requirements and followed by root cause analysis, planning and implementation of corrective actions etc., CELEBI is also conducting daily flight audit as per the Ramp Safety Checklist. CELEBI also adhere to all legal and applicable requirements through regular tracking and implementation of controls. Celebi also keeps on monitoring safety procedures. CEO/COO of CELEBI conduct weekly review of overall organizational operational performance with all HODs.

In the last Mr. Laxman Prasad proposed Annual Tariff Plan Proposal and it was mentioned that current AERA approved prices is remain unchanged from 1<sup>st</sup> April 2015, however during this period cost of operation has increased beyond inflation due to significant increase in minimum wage in the year 2017. Considering the above facts we will propose to AERA for increase of price @ 6% for FY1920 & FY2021 after a gap of four years.

After the detailed presentation, stakeholders were invited for their queries and question and answer session began:-

Mr. Dhayanithi – Madurai Trans Carrier Limited stated that at present many times they feel that no point of contact in between operator and GH other than MIAL's terminal team. He further asked if any technical support required at the time of operations how can they contact us? Also to inquire, if they want to avail credit facility, how to proceed on the same?

- CELEBI responded to the above questions with Mr. Tauseef Khan informing that there will soon be 24/7 person (Supervisor / DO) available on shift and their contact numbers will be shared shortly with all the customers for better communication. Mr. Laxman Prasad further stated Credit Facility is available and same could be discussed with Celebi's Sales and Marketing team.
- Mr. Amit Rane from Raymond's queried about Pushbacks not available at peak flight movements with trained and certified staff for flight operations. He asked for copy of Celebi's Audit Certificates to be provided to them for their audits. Also to check the possibility of Operator Passenger Manifest be stamped for filing with GVK one with operator baggage tags to be used on bags. Mr. Saurabh Dalvi stated that, CELEBI has 03 pushbacks and out of it 02 are used for pushbacks and 01 for towing of aircraft if required. He assured same will be taken up at Airport Collaborative Decision Meeting this Friday for communicating the expected time of take off to be communicated to the Pilot for charters as it is carried out for international and domestic flights.
  - Further adding to the conversation he informed that excel sheets with staff validation/ISAGO/ISO certificates to be shared 6 monthly basis.
  - For manifest copy issue to be taken up with MIAL and communicated.
- Mr. Babu Shetty from Essar asked as they have 03 Non -Mumbai based aircrafts pushbacks cannot be used for their towing in the hanger. Is this regulation from any authority and can this clause be added in agreement. CELEBI management responded to the same that we need to train staff for towing in the hanger due to other aircrafts being parked for safety concerns. To this CEO further added that it is not possible to provide this service as our insurance coverage is only for the services provided on the ramp side. Also we do not have line maintenance facility which stops us from officially doing so for any customer.
