AAI Comments / suggestions in respect of Consultation paper

No. 5/2011-12 dated 03.06.2011

This has reference to the subject paper circulated by AERA under reference No. F.No. AERA/ 20011/ mytp/ csc-pc/ 2011-12 dated 03.06.2011 regarding Multiyear tariff proposed for 1<sup>st</sup> Control Period submitted by Cargo Service Centre India Pvt. Ltd. for providing cargo handling services at Perishable Cargo Terminal. CSI Airport. Mumbai.

- 2. The Consultation Paper has been examined in consultation with the **Coordination Cell of AAI**, who is the custodian of the OMDA, and monitors compliance of the same by DIAL and MIAL.
- 3. AAI has perused the same and has following comments / suggestions which supersedes our previous communications on the proposal of M/s CSC:

## Comments on Para 3 & 7:

- As per para 7, it has been mentioned that there are 3 service providers i.e. AAI, MIAL and M/s. CSC. After telephonic discussions with MIAL, it is revealed that Air India and M/s. MIAL are the only custodian at Mumbai International Airport to handle cargo including perishables.
- M/s. CSC is providing the services on behalf of MIAL on "BOT Basis" as MIAL is appointed custodian by Customs. It is no where mentioned in the Consultation\_Paper that CSC is appointed custodian by Customs.

## **Comments on Para 10:**

- Under Clause 12.2 of OMDA signed between AAI and MIAL, M/s. MIAL is free to fix the charges for Non-Aeronautical Services. As per Schedule 6 of OMDA, cargo handling comes under Non-Aeronautical Services.
- Since M/s. CSC is providing services on behalf of MIAL who is the custodian at Mumbai Airport, the Consultation Paper does not indicate whether the consent of MIAL has been taken by M/s. CSC before finalizing the charges. However, M/s. MIAL has informed telephonically that they were associated alongwith the M/s. CSC in all their discussions with the users.
