Interim Representation by ACAAI

We recognise AERA as the sole authority for approving and notifying tariff and charges for various operations so far as Airports across the country.

We are proud that ACAAI was instrumental for inclusion of cargo in to the scope of AERA and are confident that the interest of the cargo industry will be protected by AERA.

Initially a cursory proposal was made by Hyderabad Menzies Air Cargo Pvt Ltd. to increase the tariff and we were a part of the discussion.

Subsequently, we informed HMA CPL that any tariff revision has to be routed through AERA and our mail to this effect which was responded by them confirming that they will approach you for revision and that they do not intend to increase notified rates till 31st March 2013 is enclosed.

Since HMA CPL has committed that they would not increase the tariff till April 2013 we assume that the present consultation paper available in the Website of AERA is for next financial year.

We suggest that AERA may circulate the proposal to users of HMA CPL, seek their views, call for a joint meeting before any revision is accepted.

We are confident we will have your understanding on this issue.

With regard to the above mentioned Consultation Paper - on behalf of Airline Customers of HMA CPL at Hyderabad we would like to lay before you that ..

1.1. The Rate increase proposals forwarded by HMA CPL to AERA also covers an increase in charges borne by airline customers - like build-up, break down and X-Ray Screening charges - the proposed increase in these charges have been compiled and proposed without consultation or agreement with Airline Customers. In their submission HMA CPL have only provided a document related to their agreement with the agents / ACAAI on TSP Charges and since the same has not been discussed/agreed with airline customers no document to this effect has been submitted. Since these charges are billed to airline customers and the increase directly impacts the operational cost of our services - we would request that these charges be deferred till a common agreement between HMA CPL and airline customers is reached.-
