With reference to your letter AERA/20010/MYTP/AIS/GH/Del/2012-13/4753 dated August 16, 2013 we are glad to understand that the Ground Handling Services of AISATS at IGI has been determined as material but competitive being considered under the "Light Touch Approach" to determine the tariff for first control period .

However we shall like to submit that the rates proposed by AI SATS is higher than the ceiling rates given in the Concession Agreement executed between DIAL and AI SATS.
