Dear Mr Jain

Representative of DCAAI have participated in Stake Holders Consultation Meet on 28/02/2017.

Our comments on DCSC Tariff proposal for 2016-17 are as follows:-

1. We at DCAAI object to Proposed increase of 7% in TSP charges by DCSC as Services are not provided by DCSC under TSP as defined vide AERA Order 18/2014-15.

Services as explained on page 4 para 5.1 and Area for consolidation as per page 7 para 6.4 of above mentioned order are not provided.

2. DCSC has enforced RFC since last 7 months and it is one more reason why TSP should not be charged at all, rather than increasing TSP.

3. Financial details of DCSC are not available. It is pertinent to mention that DCSC has not invested for last 6-7 years, in development of Cargo Terminal, which is a make Shift Arrangement since year 2010.

It has not facilitated the Trade in Ease of Doing Business.

4. There is no Service Levels defined/documented by DCSC for which it is charging TSP from the Trade.

5. There is No Ombudsman in the event of Dispute on Services, Payments and Loss due to theft/pilferage. Agents fraternity is bereft of opportunity for Natural Justice.

In view of all above it is once again reiterated that Tariff should be maintained Status Quo Ante.
