Subject: Multi Year Tariff Proposal and Annual Tariff Proposal ( FY 2016-17 to FY 2020-21 ) for the Second control period in respect of M/s Bharat Star Services (Delhi) private limited (BSSDPL) for providing Into Plane services at IGI airport, New Delhi.

Dear Sir,

This has reference to the Consultation Paper number 03/2017-18 dated 27<sup>th</sup> April, 2017 seeking our comments on the subject Tariff proposal.

BSSDPL has sought revision in Into Plane (ITP) charges from FY 2016-17 to FY 2020-21. As per AERA order no.11/2016-17 dated 23<sup>rd</sup> September 2016 issued on 29<sup>th</sup> September 2016, Independent Service Providers were allowed to continue levy of tariffs existing as on 31-03-2016 for a period of six months w.e.f. 01.10.2016 or till determination of tariffs for the second control period, whichever is earlier.

It may be noted that ITP charges are pass through item. As per AERA order mentioned above we are charging tariffs existing as on 31-03-2016 to our customers. Any revision from retrospective basis would make it difficult for us to recover the amount from our customers resulting in financial loss to us.

**In View of above, any revision in the Into Plane (ITP) charges should be approved on prospective basis only.**
