Subject: Consultation Paper numbers 01/2018-19 dated 10th April, 2018\_Into Plane Service Charges at Mumbai airport

Dear Sir,

This has reference to the Consultation Paper No. 01/2018-19 dated 10th April, 2018 regarding Tariff proposal in respect of M/S Bharat Stars Services Pvt. Ltd (BSSPL) For Providing Into Plane Services at Mumbai Airport.

AERA has proposed Into plane charges at Mumbai Airport for BSSPL at 300.06 Rs/KL for 2018-19 with 5% increase year on year for FY 2019-20 and 2020-21.

In this context, we would like to bring to your kind attention that, as per order no 28/2017-18 dated 8th December 2017, Into plane Service charge for IOSL at Chatrapati Shivaji International Airport, is 265.72 Rs/KL for FY 2018-19. In our view since the service provided is of similar nature, Into plane charges at the same airport cannot be different for different operators. The same practice is followed at other airports like Delhi and Bengaluru where such services are provided by IOSL and BSSPL. Further Into plane charges are pass thru item in pricing and hence it will be inappropriate to charge different charges for different customers at the same airports basis which agency is providing the service to particular customer. To avoid the disparity, we request that ITP charges for BSSPL should also be fixed in line with order no 28/2017-18 dated 8th December 2017.
