This has reference to the Consultation Paper number 32/2018-19 seeking our comments on the subject tariff proposal is respect of M/s India Oil Skytanking Pvt. Ltd. for providing into plane services at CSI Airport, Mumbai.

In this context, we would like to bring to your kind attention that, as per order no 12/2018-19 dated 29<sup>th</sup> May 2018, Into plane Service charges for BSSPL at Chatrapati Shivaji International Airport, are fixed at 279.00 Rs/KL for FY 2019-20 & 292.95 Rs/KL for FY 2020-21. In our view since the service provided is of similar nature, Into plane charges at CSI Airport should be same for all ITP operators.

We request that any future revision in Into Plane charges should be approved on prospective basis only.
