Sub.: Comments on Consultation Paper No. 09/2022-23 dated 17.8.2022

We refer to the Consultation Paper No. 09/2022-23 dated 17.8.2022. At present import and export is facing delay in clearance due to issues faced with various stakeholders such custodian, customs, PGA, airlines etc. We request that the proposal for reduction in demurrage free period should be considered only after prescribing SOP with specific time limit for entire activity with stakeholders such as Custodian, Customs, PGA's airlines etc.

The following points may be noted:

- Right from landing of the cargo, i.e. flight checking, segregation, forwarding and delivery of cargo and vice – versa for exports, there should be specific time limit fixed with Custodian. At present the time limit being projected are not actual, and they need to be captured in EDI System on real time basis and monitored.
- There is need to create robust infrastructure at ACC Mumbal. The present infrastructure was created decades ago and to cater to the present cargo volumes, we need better infrastructure.
- 3) Due to frequent breakdown of Customs EDI system and ICEGATE, it is resulting delay in entire process of clearance. We request that Custom Authorities should also be part of stakeholder consultation process and time limit needs to be set for Assessment and other activities.
- Likewise of PGA's such as ADC, PQ, AQ, FSSAI, Textile Committee etc, we request that specific time limit for issuance of NOC should be prescribed. It is taking anywhere between 2 – 7 days for NOC from PGA.
- The flight segregation time and inward date which is being reflected is not accurate and there is urgent need to provide this information on real time basis. We are enclosing submission made regarding the same

Considering the above, we once again request that reduction of demurrage free period should not be considered.

We look forward to your co-operation in the matter in larger interest of EXIM Trade at ACC Mumbai.
