Dear Sirs,

This is further to subject meeting held on 15th September 2023, we would like to provide our feedback as below:

As we have initially clarified that AI Airport Services Limited (Formerly known as Air India Air Transport Services Limited) ("AIASL") is a fully owned subsidiary of AI Assets Holding Limited ("AIAHL") is an authorised Ground handling company to perform the Ground Handling services (Ramp, Passenger, Baggage, Cargo Handling and Cabin Cleaning) at Indian Airports as per GH policy.

AI Airport Services Limited is a leading ground handling service provider in India and offers ground handling services at major airports in India. AIASL presently provides ground handling services at almost total of 113 airports (Online 81 airports & 32 offline airports).

As on date, GMR Goa International Airport / Manohar Parrikar Airport – MOPA is operationalised since January 2023 for Domestic Scheduled and Non-Scheduled flight operation. We, as AIASL, have already intimated that we are ready with full-support of resources (GSE and Manpower) to provide GH handling to all client airlines at MOPA Goa International Airport.

As per directives of Ministry of Defence (MoD), we are already having Ground Handling Agreement for handling all Indian Air Force (IAF) VVIP/SESF and communication/Non-VVIP flights at all Indian Airports including GMR Goa International Airport / Manohar Parrikar Airport – MOPA. We have been communicated by IAF to confirm our preparedness for handling of their flights at this Airport wherein we have

been seeking your support to allow AIASL to perform Ground Handling function / services at this airport.

We request to kindly refer to latest AIC No. 03/2022 dated 25<sup>th</sup> February 2022; Clause 1.3 which states as follows:

Quote:

**"1.3 Rule 92 of the Aircraft Rules, 1937 provides that the licensed public aerodromes shall, while providing ground handling services themselves, ensure a competitive environment and allow the ground handling service providers permitted by the Central Government to provide ground handling to such aerodromes without any restrictions. These ground handling service providers shall, however, be subject to security clearances of the Central Government. As such, it is for the Central Government to decide the agencies, which can provide ground handling services at various aerodromes and also the eligibility criteria for such service providers."**

Unquote:

Kindly be informed that AIASL is an authorised Ground Handling Agency (GHA) with necessary security clearances from the Central Government / BCAS. Further, as per the above clause, we have appealed to GMR Top Management to consider appointing and allowing AIASL to perform Ground Handling services at GMR Goa International Airport / Manohar Parrikar Airport – MOPA as the Airport Operator should ensure a competitive environment for performing Ground Handling services.

As it is to highlight that presently only one Ground Handling Agency is providing GH services at this MOPA airport. Looking into the potential growth of this airport, an additional GH Agency will provide a healthy competition minimizing the monopolistic disposition of the airport.

The above comment is for your kind consideration.
